I am delighted to see that there is a proposed move from using Oaklands Junior school to st Sebastian's memorial hall. I still don't understand why in this modern age - voting online or postal system is not used. Sustainability and education are the most important things to consider. Please cut down on missed school days, missed work days (having to look after children) and excess traffic / pollution by considering postal / online systems..

This community has lost enough school time for our children from using Oaklands Infant and Junior schools as the polling station for so many years. This is no longer practical - and the education of the children is far more important given how much schooling they have lost due to the pandemic. St Sebastian's is more than adequate to serve as an alternative location for this area.

An even better alternative might be the Church of the Holy Ghost on New Wokingham Road. Using our schools must be avoided wherever possible.

Please approve additional car parking spaces around ST Sebs Memorial Hall to make it accessible.

Oaklands Junior School was not available to select on the previous page. Why is this the case?

As a parent and a local resident, the use of this school is detrimental to the to the local community. It is unbelievable that the local officials feel that it is acceptable for our children to loose out on vital learning when their education has been so disrupted over the last 3 years. The staff, parents and children are doing so much to "catch-up" from the disruption and should not be penalised just because the local elected officials fail to consider an appropriate alternative. It is not just one school that is disrupted, it is 3, the Juniors, the Infants and the Nursery. This is around 400-450 pupils, which easily means over 600 families are impacted by continued use of this venue (number of which are being financially penalised, including myself, as they are having to take time off work for childcare - how is this acceptable?). I'm certain that I read something from the Education Secretary advising that local authorities needed to examine use of school venues and take all steps to avoid disruption to pupils. Feels like this has fallen on deaf ears?!

I understand that the venue has to have easy access however, have any of you checked the local roads on election days? It is absolute carnage. The school is too close to a parade of local shops, so the congestion in the area is horrific. This is a safety aspect that is being ignored and again poses a risk to our children, as they are likely to be outside playing because they cannot attend school due to this exercise.

I fail to understand why other central, easy access venues such as venues at Pinewood (like Scout huts) could not be used. Equally venues in the village, such as Crowthorne Parish Hall, or the hall connected to St John the Baptist Church cannot be used.

If these are not big enough (although I would say that they are equal to the hall at the Junior School), then why cannot funding be assigned to hold this at a venue such as Wellington Sports Centre.

All of these venue have step free access and there is parking available.

Whilst my comments are specific to our school, I believe that alternatives should be sourced for all impacted schools in the borough.

Why is Oaklands Junior School not available for selection?

I have lived in Crowthorne for over 30 years however, for the last 7 years (although I suspect it has been longer), the local authority has chosen to use our local school as a polling station. This is unacceptable due to the significant disruption it causes for our children. They have lost out on a tremendous amount of education time over the last 3 years and adding to this disruption for the benefit of local counsellors is completely unacceptable. Over 400 children have to miss out on a days education and I fail to see why an alternative venue cannot be sourced - the school was never used when I was a pupil.

I also live close to the school - adjacent road to Butler Road, and the traffic chaos on polling day is absolutely horrific. I've not been able to exit my drive on a number of occasions and I've seen a number of near miss comparisons over the years. The roads around the school are congested on a normal school day, but add to this with the number of local residents, all of which tend to drive and not walk to the venue creates sheer carnage.

This is so disruptive to the children not being able to attend the school. After Covid every school day matters. There is very limited parking which means the streets are very congested.

Oaklands Junior school is not suitable as it means closing 3 educational facilities each time, Acorns under 5's, Oaklands Infants & Oaklands Juniors.

This is outside of the population centre.

To access requires a significant walk by most voters and the crossing of a very busy nine mile ride junction.

Driving- severe lack of parking places.

The Quinquennial Review of Polling Places held in 2018 exhaustively considered every possible alternative to using Oaklands Junior School Hall and reluctantly concluded that no other location met the requirements of the Electoral Commission for polling places. As basically nothing has changed in the Electoral Commission requirements, or the various halls in the ward, it is difficult to understand why this change is proposed apart from the wish not to close schools for elections, something that I am very willing to endorse in principle.

St Sebastian's Memorial Hall is on the fringe of the mass of housing in the Wokingham Without ward where well over 95% of the electorate lives south of Nine Mile Ride. Although the Memorial Hall has step free access it located in an awkward position on the north side of Nine Mile Ride which is a busy east-west route through the ward and has no street lighting to the east of the hall.

Vehicle parking is restricted and any polling place should be able to cope with the greater turnout at a general election as well as being suitable for one held in winter with short hours of daylight. For a general election, 3 polling stations would be required for the current electorate in Wokingham Without, each having a Presiding Officer and 2 polling clerks who are all likely to have cars making 9 in total that would then fill half the parking spots.

The busiest time (late afternoon and early evening) for polling coincide with the heaviest traffic on the roads and that is particularly true on Nine Mile Ride. All it needs is to have one car manoeuvring to park in the limited spaces and traffic will be held up in both directions on Nine Mile Ride, with cars waiting access to park. This even applies to those turning up for a Pilates class so illustrates what is likely to happen if used as a polling place.

There is no convenient on street parking adjacent to the hall; Honey Hill

The obvious solution is to retain the Oaklands Junior School Hall as the polling place for the ward. It is central to the mass of housing in the ward, it is residential roads with on-street parking (even though there are school hour parking restrictions in Butler Road that could be lifted on polling days) and all the roads have streetlighting with 30 mph limits. Being central this encourages walking and cycling to access the polling place.

I appreciate that Wokingham Without is unusual in only having a single polling place for what was and will be a 3 councillor ward with some 6,300 electors currently. It would be possible to split the ward into 3 or more PDs to enable other polling places to be used. But this has not been carried out because, quite simply, it has previously been decided that there is no other location suitable for use as a polling place.

There are currently planning permissions granted for some 1,750 in the South Wokingham SDL area south of the Wokingham to Bracknell railway and it is understood that there are plans for about another 1,000 within the SDL. It is also understood that there are plans for

There is no change to PDs FCB or XWB or the Wokingham Without ward boundaries as a result of the Electoral Review. As mentioned earlier, when house building begins in the SDL area south of the railway, the SDL area could be designated as a separate PD (and warding considered for Wokingham Without Parish Council) although electors would either vote by post or at the polling place that should be retained in Oaklands Junior School until a hall is constructed and available for use as a polling place within the PD/SDL.

has no street lighting and is narrow. The speed limit at that point on Nine Mile Ride is 40 mph and eastbound cars on Nine Mile Ride often approach the Honey Hill junction indicating left with the indicators not cancelling after the New Wokingham Road roundabout, when in fact they are continuing along Nine Mile Ride, making a hazard for the unwary trying to turn out of Honey Hill.

Being on the fringe of the housing area in the ward will reduce the numbers walking and cycling to the polling place, increase those trying to drive to it and is likely to reduce turnout in elections contrary to Electoral Commission aims.

There are footpaths through to Royal Oak Drive, Queens Ride, Hatch Ride and Holmbury Avenue but all are unlit, mainly through woodland, which will largely negate use after dark.

In summary if a Risk Assessment were to be carried out this is likely to identify 4 risks as follows:

Congestion in parking leading to hold-ups in Nine Mile Ride and the possibility of minor bumps in parking -especially after dark.

Congestion and a higher risk of collision resulting from turning into the St Sebastian's Memorial Hall car park and in turning out of Honey Hill.

Increased hazards to voters crossing Nine Mile Ride twice - particularly with increased car movements.

A reduced turnout of voters primarily because of the location on the fringe of housing in the ward (compared with the central position of Oaklands Junior School) although I appreciate that there are many variables affecting turnout so that judgement will be subjective. However, as the aim of a Polling Station Review is to identify the most suitable locations to

a community centre which will presumably have a hall suitable as a polling place and it would seem then to be logical to designate that are as a separate PD. However, as houses are likely to be occupied well ahead of the construction of any community centre they would need to use the existing polling place and, while Oaklands Junior School could take extra electors arguably St Sebastian's Memorial; Hall could not without causing gridlock on Nine Mile Ride.

Parking within the school grounds is adequate for those voting and for polling staff. I appreciate that the closure of the schools for polling day is unpopular particularly with working parents and that the additional bank holiday this year for the King's Coronation meant that there were 3 bank holidays in May plus a closure for use as a polling place. I see no reason why the Acorns Pre--school need close: that could use the Ellis Road entrance. The schools could mitigate the inconvenience for parents by holding Inset days concurrent with polling days with the Infant School playground being used for school staff parking.

St Sebastian's Hall is on the very edge of the population centre of the ward and for many voters is a considerable walk which ends with having to cross the busy Nine Mile Ride where there's no crossing provision. The result of this is that more voters will drive, there is limited parking and potential traffic congestion making crossing the road even more dangerous. I think it is also likely that turnout will be reduced as some voters will not bother or be able to make the journey.

Oaklands School appears to be the only alternative available. I realise that it is not ideal as it causes a school closure for the day but due to the unusual nature of Wokingham Without, almost all the community facilities are outside the Ward. The Pinewood Centre is another option, but is arguably less accessible than St Sebs, although the parking wouldn't be an issue.

St Sebastians Hall is on the edge of the polling area. Whilst it is good to remove it from Oaklands school, to keep it open, most people will have to use a car to access this. There will not be enough parking at St Sebastian's. Not enough parking: There just aren't enough parking spaces. When it gets busyl voters might struggle to find a spot. With parking restrictions on the Nine Mile Ride, some might end up parking far from the polling station, or they might not vote at all because it's just too much trouble.

Too much traffic: The polling station is near a road that gets really busy, especially during rush hour. More cars coming in for voting could make the traffic jams even worse.

It could be dangerous: The increase in cars could make the roads around the polling station more dangerous. The roads aren't built for a continuous stream of voters driving in and out all day. Plus, with folks needing to walk and cross the street from nearby houses, the risk of accidents is higher.

In a nutshell, the chosen spot could lead to parking problems, bad traffic, and safety risks. Finding a different place with more parking and away from the busy roads, or improving the current spot by managing traffic better and adding more parking, would make voting easier and safer for everyone.

It might need to stay at Oaklands. Both my daughters went to this school and it did not impact their education.

Maintaining the current school as the polling station is a sensible choice. It's positioned away from the busier main roads in a residential area, providing a safe and quiet environment that reduces the risk of traffic-related issues. The parking facilities are ample and similar to those at the proposed new location, which ensures convenience for voters. Additionally, the school's easy accessibility could encourage a higher voter turnout among local residents.

If we could align voting day with an Inset day, it would prevent any disruption to children's education. This approach offers a balanced solution that prioritises both community safety and educational needs.

This Council believes that residents should receive the infrastructure and amenities they are promised when they buy a new home and that developers and this council should be held accountable for their legal obligations within major S106 agreements. For clarity, the major sites refer to SDL sites and other large sites only.

This Council will produce a **biannual** report detailing performance against financial, programme and other obligations of all parties within **major** S106 agreements of which this Council is a party. The report will be issued to all members of this council and relevant community groups.

Increasing transparency on performance against commitments will provide confidence to communities that promises will be delivered on. This Council will learn the lessons from delays in the delivery of the Arborfield Green Village Centre and other facilities and amenities across the SDL.
