SUMMARY OF REPORT

This report details the proposed response of Wokingham Borough Council to the consultation on the Draft East Basingstoke and Redlands Development Brief Supplementary Planning Document

The content of this report includes the following:

 Considering the impact of the Draft East Basingstoke and Redlands Development Brief Supplementary Planning Document on Wokingham Borough.

Background

Basingstoke and Deane Borough Council is consulting on the Draft East of Basingstoke and Redlands Development Brief Supplementary Planning Document (SPD). It has not been possible to gain executive member sign off by the deadline of the consultation on 3rd March 2017 and this report has therefore been sent as a holding response subject to official sign off.

East Basingstoke and Redlands are two sites in close proximity to each other which have been allocated for a total of 615 dwellings through the Basingstoke and Deane Local Plan 2011 – 2029. The Basingstoke and Deane Local Plan was adopted in May 2016, and therefore the principle of development of the site has already been accepted. The sites lie just to the East of Basingstoke Town, and the principal access will be off the A33.

The East Basingstoke and Redlands Development Brief SPD essentially adds extra detail to the site allocation policy, and will be a guide for future development within the two sites.

Analysis of Issues

The SPD sets out development principles covering topics such as provision of a primary school on the sites, design principles of the sites, and the provision of green infrastructure. The matter that is of concern to Wokingham Borough Council is the effect that the new development will have on traffic on the north of the A33 (within the Wokingham Borough boundary) and on junction 11 of the M4. It is also unclear whether the Highways Authority has considered the impact of the East Basingstoke and Redlands site allocations on the Manage Motorways project on the M4 (hard shoulder as a running lane).

Paragraph 5.1.16 of the SPD states that in preparing planning applications for the sites, the planned improvements to the A33 and any other strategic improvements to the local highway network will need to be considered through liaison with the Local Highways Authority. Wokingham Borough Council endorses this approach and requests that the concerns regarding the impact of development on the A33, junction 11 of the M4 and the Manage motorways project are taken into consideration.

It is also noted that there is a potential later phase for 450 dwellings to be delivered on the site beyond the plan period which is up until 2029. As mentioned in the previous paragraph of this response, Wokingham Borough Council requests that the impact of this increase of development on the A33, junction 11 of the M4 and the Manage Motorways project is considered.

Joint working should continue between the Wokingham Borough Council and Basingstoke and Deane Borough Council and Hampshire County Council on strategic matters such as highways, as large strategic development proposals progress.

FINANCIAL IMPLICATIONS OF THE RECOMMENDATION

The Council faces severe financial challenges over the coming years as a result of the austerity measures implemented by the Government and subsequent reductions to public sector funding. It is estimated that Wokingham Borough Council will be required to make budget reductions in excess of £20m over the next three years and all Executive decisions should be made in this context.
