OUTCOME / BENEFITS TO THE COMMUNITY

The reduction in the speed limits along Fleet Hill and The Village will help accident prevention along these roads and create an environment that is safer for all road users.

RECOMMENDATION

That the Executive Member for Highways and Transport:

- 1) approve the making of the Wokingham Borough Council (B3348 Fleet Hill, B3348 The Village) (40mph Speed Limit) Order 2017, as advertised;
- 2) authorise officers to inform respondents of the results of the consultation accordingly.

SUMMARY OF REPORT

Following a number of accidents and concerns from local residents, Wokingham Borough council are considering reducing the speed limit on Fleet Hill from 50mph to 40mph. This is in the section between the Tally Ho pub and the western edge of Finchampstead Village

The formal consultation for the Traffic Regulation Order (TRO) generated 17 responses covering various issues detailed within Appendix A. Assessment of these responses has indicated there were 14 in support, the police had no objection and one respondent objected.

Following full consideration of the objection received it is the officers' recommendation to proceed as advertised. Subject to the Executive Member's approval, this new 40mph speed limit TRO will be introduced in late 2017, and all those that responded to the consultation will be informed accordingly about the outcome of the process.

Background

Following a number of accidents and concerns from local residents, Wokingham Borough council are considering reducing the speed limit on Fleet Hill from 50mph to 40mph. This is in the section between the Tally Ho pub and the western edge of Finchampstead Village.

Consultation

The formal consultation for the proposed TRO was undertaken by means of a newspaper advert, on-line access to maps and TRO documents, letter drops to all local residents affected and emails to statutory consultees. It ran from 13th July 2017 through to 6th August 2017. Of the 32 responses, 27 were in support, the police had no objection, one made a comment (but did not state they support or object) and there were three objections.

Analysis of Issues

The three objectors' comments can be summarised as follows:-:

- The current speed limit is already 10 mph below the National Speed Limit and the road does not appear to pose any significant risks from a safety point of view.
- Is the consultation for the speed limit open to the views of other road users and not just residents?
- The proposed reduction in speed limit will result in yet another unsustainable 40 limit which the vast majority of drivers would consider too low
- A local resident (of over 15 years) can't remember any serious crashes and there
 are no schools, shops or other amenities people maybe using, and so therefore
 does not feel a speed reduction is necessary.
- Another resident states that the current 50mph limit (which was previously a
 derestricted 60mph limit) was unnecessary as no new drives or access roads have
 been added in that entire period. They don't wish to see any new access roads
 added and view any reduction in limit as more likely to give rise to additional
 property development, and so would like the current limit either to remain or the
 previous derestriction reinstated.

The proposal to reduce the speed limit from 50mph to 40mph along B3348 Fleet Hill and The Village, Finchampstead was initially requested by local residents, who have concerns with the number of accidents taking place along this section of road. Looking at the personal injury accident data on this road for the last five years (1st July 2012 to 30th June 2017), there were ten PIAs reported on this road, of which one was a serious accident and the other nine were slight accidents. This does not however include a number of non-reported incidents, which would include non-injury collisions or near misses, which we have heard about from local residents. From the personal injury accident reports, it seems that that all of the ten reported accidents were either due to drivers travelling too fast for the conditions and/or the alignment of the road.

The positive benefits in reducing the speed of vehicles along this section outweigh the slightly longer travel time that motorists will experience due to the reduced speed. It will take approximately 18 seconds longer to travel one mile at 40mph then it would have at 50mph; it is anticipated that this will have no discernible impact of traffic flows along Fleet Hill and The Village. A speed survey in February 2017 stated that the mean speeds along this section of road were 39.2mph eastbound and 38.6mph (w/b), with the

85%th percentile having speeds of 45.3mph and 45.0mph, respectively. This indicates that the proposed reduction in speed limit complies with the police's criteria for the enforcement of a 40mph speed limit. This supports the view that a reduction in speed limit to 40mph is both appropriate and should help deter excessive speeding in turn leading to a reduction in the severity (and hopefully the frequency) of injuries occurring. Highways Engineers are also currently designing additional local safety measures on this section of road to address any issues with the alignment or highway condition generally.

The formal consultation for the TRO included a letter drop to all residents living on Fleet Hill and The Village that are adjacent to the section of road upon which the TRO is being proposed. The usual statutory consultees (e.g. Emergency Services, Transport Companies, Local Members and the Parish Council) were also contacted. The proposals were also advertised in the local press and by street notices – these were located at the extremities of the proposed speed limit along the route. All documents were also placed on the Wokingham Borough Council website and were available to view at the Shute End Council Offices. This demonstrates that the formal consultation for the proposed Traffic Regulation Order complied with the appropriate regulations and was indeed available to the wider general public for comment.

As to the concern regarding any additional property developments along that section of road, this would be a matter for further assessment as and when any planning applications are considered.

Recommendation and Conclusion

On this basis officers do not consider there are any substantive grounds to uphold the objections, and that given the level of general support this proposal has received therefore recommend proceeding to make the Traffic Regulation Order as proposed.

FINANCIAL IMPLICATIONS OF THE RECOMMENDATION

The Council faces severe financial challenges over the coming years as a result of the austerity measures implemented by the Government and subsequent reductions to public sector funding. It is estimated that Wokingham Borough Council will be required to make budget reductions in excess of £20m over the next three years and all Executive decisions should be made in this context.
