Better Ofsted Outcomes in schools based on better pupil achievement

RECOMMENDATION

To note and support the actions identified.

SUMMARY OF REPORT

Changes in Ofsted methodology in the past two years have presented challenges to schools. The overall impact in Wokingham is positive, with areas for further focus in relation to the proportion of schools requiring improvement

Background

Since the last Overview and Scrutiny Committee report in 2013, several further schools' OFSTED inspections have been published at <u>http://www.ofsted.gov.uk/schools/for-schools/find-school-inspection-report</u> (please see section 1.6).

The Ofsted data viewer at <u>http://dataview.ofsted.gov.uk/</u> currently shows data on schools' Ofsted performance, relating to 30th March 2014. Data from this public source is used in the annexes to this report. Below is an analysis of the current position of Wokingham schools, set against a context of national changes and national performance.

Analysis of Issues

Changes in Ofsted Criteria

The new inspection framework in September 2012 placed a greater focus on the progress made by all pupils in all year groups across a school, rather than their attainment at the end of the key stage. This has been the most significant of a number of changes in the framework in the past two years. Another has been an emphasis on the performance of vulnerable pupils within the overall cohorts. This signaled a change in how schools' effectiveness is judged. Where there are wide gaps between the performance of vulnerable pupils and others, and where pupils, especially able pupils, do not make good (ie better than expected) progress, schools have been vulnerable to adverse Ofsted judgements. This has affected schools nationally and in Wokingham.

Impact in Wokingham

The key Ofsted judgement for Local Authorities is the percentage of their pupils attending good or outstanding schools. <u>Annex 1</u> shows the 2012 and 2013 percentages for England, the SE region and Wokingham. SE regional figures are also a rough proxy for statistical neighbours, whose figures are not made available by Ofsted. Analysis shows:

- More WBC pupils attended good or better schools than regionally or nationally in 2013 (86%/78%)
- The proportion of WBC good or better schools rose more than regionally or nationally from 2012 to 2013 (+13%/+9&10%)
- WBC schools requiring improvement fell more than regional or national (-13%/-9%)
- WBC maintained a position of nil inadequate schools
- Whilst good or better figures favour WBC, the % outstanding fell more than national or regional, as the % of good rose significantly more, from below benchmarks to equal.

Looking at figures by phase, the more detailed picture is:

- Outstanding primary schools fell by 1% in WBC, SE regional and England, WBC remaining above benchmarks
- Outstanding secondary schools fell more in WBC than elsewhere but were still significantly above others
- · Good primary school figures grew less in WBC than elsewhere, falling below others
- Good secondary schools grew much more in WBC than elsewhere, improving from well below to comfortably above others
- · RI primary figures improved less than others, moving from around benchmarks to worse
- RI secondaries improved strongly to nil%
- In a context of low numbers, WBC special schools and PRUs compare well with others

Thus the overall Wokingham position is strong. Within that, there are

 Concerns for outstanding schools and congratulations for those which have remained so in a regime which has been challenging nationally

- Commendable strengths in secondary & special schools, the Nursery school and PRUs
- Concerns around good/RI primary schools; the balance between these having improved, but less than benchmarks

<u>Annex 2</u> shows the percentage of schools by Ofsted judgement. That is different from the percentage of pupils attending them because of their different pupil numbers. The latest figures available suggest:

- Overall figures for the percentage of good or better schools are better than others
- · Wokingham's figure of nil inadequate schools is a consistent strength
- The nursery school is to be congratulated
- WBC has more outstanding primary schools than others
- We have fewer good primary schools and fewer good or better
- There are more primary schools requiring improvement in these figures
- Secondary performance is strong, but less far ahead at the outstanding level
- Special school and PRU performance is strong

<u>Annex 3</u> is a school-by-school account of Ofsted judgements. Analysis of their inspection reports shows that:

- Where schools have retained an outstanding judgement, achievement remained outstanding and pupil progress was excellent. The school makes excellent provision for those pupils who are eligible for pupil premium funding
- Where schools remained good rather than progress to an outstanding judgement, inspectors judged there was not enough consistently outstanding teaching or that pupil premium funding was not sufficiently sharply targeted or evaluated.
- Where schools dropped from an outstanding judgement to good, inspectors judged that pupils' progress over time was good rather than outstanding.
- Where schools dropped from a good judgement to one requiring improvement, inspectors judged teaching to not be consistently good or provide sufficient challenge so that rates of progress were variable for different groups of pupils.
- Where schools did not improve on a judgement of requiring improvement, teaching
 was judged to be inconsistent over time and more able pupils insufficiently
 challenged.
- Where schools did improve from a judgement of requiring improvement to one of good, inspectors judged that teaching was good so that pupils make at least good progress. Inspectors also recognized the strong leadership of the Headteacher, well supported by senior leaders and members of the governing body.

LA School Improvement Actions

School Improvement Officers (SIOs) have continued to challenge and support schools including using the experience of head teachers who had improved the inspection category in their own schools. For example a recent inspection showed how the SIO had demonstrated swift and decisive action in leading a school review as a result of concerns expressed about the school. This led to urgent action by the school in response to the LA report which was acknowledged by the lead inspector who stated that there was 'robust' support provided by the Local Authority. Positive comments on LA action have routinely been made by inspectors.

School Improvement Officers coordinate planned actions to challenge and support all schools. This includes working with senior leaders and governors; brokering and commissioning effective support; setting up School Improvement Boards (SIBs); and leading school reviews. Decisive and urgent action is taken where necessary and this has led to improved outcomes for children and young people as well as improved Ofsted judgements, (see above). There are nevertheless concerns about the proportion of good and RI primary schools as noted above, and action is being taken to refocus activity so as to improve these indicators in the interests of pupils' achievements and life-chances. On that basis we would

expect four of our schools currently graded as requiring improvement to be judged as good if inspected by Ofsted in the next term.
