1. Consultation on legislation on indemnity insurance

Launch date: 22 February 2013 Closing date: 17 May 2013

The Department is consulting on draft regulations on the requirement for all regulated healthcare professionals to hold an insurance or indemnity arrangement as a condition of their registration with the relevant regulatory body.

Many healthcare professionals are already covered by their employer's arrangements. In the first instance, it will be for each individual to assure themselves that they are covered by an insurance or indemnity arrangement appropriate to their scope of practice.

2. Direct payments for healthcare consultation

Launch date: 1 March 2013 Closing date: 26 April 2013

This consultation proposes changes to the regulations for direct payments for healthcare. Direct payment, where money is given directly to an individual for the management of their NHS care, is a means of managing a personal health budget. They are currently only lawful within Department of Health approved pilot sites.

The Government's proposes to roll out personal health budgets, extending the use of direct payments so that they can be offered throughout the country.

The consultation details proposed changes to the current regulations proposed as a result of findings from the pilot programme and discussions with personal health budget holders, healthcare professionals and other organisations.
