## Department of Health 'live' consultations

### 1. Migrant access to the NHS

Launch date: 3 July 2013 Closing date: 28 August 2013

The Department of Health is consulting on migrants' access and financial contribution to the NHS. It asks who, in future, should be charged, for what services and how the system can be better able to identify patients who should be charged.

The consultation includes proposals to:

- make temporary residents from outside of the European Economic Area contribute to their healthcare cost with a levy that then enables them to access NHS services when they require them, or through health insurance or other options
- cease free access to primary care for all visitors and tourists
- more effectively claim back reimbursement from the home countries of patients

visiting from within European Economic Area

• introduce more practical and easier ways for the NHS to identify whether someone is not eligible for free healthcare.

### 2. Improving corporate accountability in health and social care

Launch date: 4 July 2013

Closing date: 6 September 2013

The consultation details proposals that all directors of providers registered with the Care Quality Commission (CQC) must meet a new fit and proper person test. The CQC will be able to insist on the removal of directors that fail this test. Where providers fail in the care that they provide, the CQC will be able to consider the provider's board and individual directors' role in this – with the power to prosecute in the case of serious failure.
