# NHS England 'live' consultations

# 1. Improving general practice – a call to action

Launch date: 14 August 2013 Closing date: 10 November 2013

NHS England is seeking views to help shape the future of general practice services in England.

NHS England engaged with GPs, CCGs and others. It found that general practice and wider primary care services were facing increasingly unsustainable pressures and that there was a need to transform the way general practice provides services to reflect growing challenges. These include an ageing population, workforce pressures, increasing pressure on financial resources, dissatisfaction with access to services and inequalities in access to and quality of primary care.

Comments will be used to help develop a national strategic framework which CCGs and Area Teams will use to organise primary services locally.
