1. Consultation on draft regulations and guidance for implementation of part 1 of the Care Act in 2015/16.

Launch date: 6 June 2014 Closing date: 15 August 2014

The Department of Health is seeking views on draft regulations and guidance on the care and support reforms in the Care Act 2014 which will come into effect in April 2015.

The consultation details a summary of the policies that the regulations and guidance relate to and the questions that the Department of Health is seeking views and evidence on. It is suggested that the consultation should be read alongside the draft regulations and guidance.

The guidance is intended to provide councils with the information they require about how they should meet the legal obligations under the Care Act and the regulations, and

will be used by council officers to plan care and support. The guidance will also be used by people using care and support, their families, the voluntary sector and care and support providers to help them to understand the new system.

2. Standardised packaging of tobacco products: draft regulations

A consultation in April 2012 sought views on the policy of standardised packaging for tobacco products.

The Government has not yet made a final decision on whether to introduce standardised packaging.

The consultation seeks to gain any additional information that may be relevant to standardised packaging which has arisen after the 2012 consultation. It includes draft regulations which highlight how requirements for standardised packaging would work in practice.
