1. Care Act 2014: funding allocations for new adult social care duties

Launch date: 31 July 2014 Closing date: 9 October 2014

Local authorities will be granted new duties as part of Care Act 2014. The Department of Health is seeking views on how the funding for 3 of these new duties will be allocated.

The 3 duties and funding available in financial year 2015 to 2016 is as follows:

- additional assessments for the cap on care costs: £175 million
- universal deferred payment agreements: £108.5 million
- social care in prisons: £11.2 million

The funding for the first 2 duties will be paid to local authorities as a Department for Communities and Local Government revenue grant and the funding for social care in

prisons will be paid as a Department of Health revenue grant.
