# Background

The application to vary the premises licence PR0288 for Old Blades Garden was received on 2 May 2012.

The following documentation is attached – copy of the application (Appendix One), location plan (Appendix Two) and a copy of the existing licence (Appendix Three).

The application was checked and confirmed to be correctly made. The 28 day consultation period ran until 30 May 2012. The responsible authorities, ward members and town council were advised of the application by email.

Details of the application are as follows:

Provision of Live Music, Provision of Recorded Music, Provision of facilities for dancing, (indoors and outdoors):

- 2300 to 0000 hours Wednesday and Thursday
- Current licence until 2300 Wednesday and Thursday
- No change to midnight Friday and Saturday hours or 22.30 hours Sunday

Late Night Refreshment (outdoors):

- 2300 to 0030 hours Wednesday to Saturday
- Current licence until midnight Friday and Saturday

Sale by retail of alcohol, (on and off the premises):

- 2300 to 0000 hours Wednesday and Thursday
- Current licence until 2300 Wednesday and Thursday
- No change to midnight Friday and Saturday hours or 22.30 hours Sunday

Addition of Health and Safety Conditions

• Add conditions 1-6 as agreed by the applicant and the Health and Safety Responsible Authority as attached as Annex One to the application

The application has been advertised correctly, with a site notice displayed at the premises (checked 16 and May 2012) and a notice placed in the Henley Standard on 11 May 2012.

Mandatory Conditions

Mandatory Condition - supply of alcohol

- 1) that no supply of alcohol may be made under the premises licence
- (a) at any time when there is no designated premises supervisor in respect of the premises licence, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended: and
- 2) that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence

Mandatory Condition - door supervisors door supervisors must be licensed by the Security Industry Authority

#### Annex 2

#### Conditions consistent with the Operating Schedule

a) General

Good general signage to be provided where possible - "exit", "entrance", "fire exit" signs to the marquee, "no unaccompanied children", "no alcohol sales to under 18", "proof of age for purchase of certain goods may be required"

#### b) Prevention of Crime and Disorder

Staff numbers will increase during the busier times so that a better eye can be kept on the whole site at all times Plastic glasses to be used wherever possible, ie all pints, half pints, paper cups for coffees etc Plenty of lighting for the whole site

#### c) Public Safety

Health & safety, risk assessment, fire risk assessment policies will be in place

#### d) Prevention of Public Nuisance

Music will be kept to a sensible level during opening periods & will stop at midnight Customers leaving the site will be reminded to be quiet There will be no movement of vehicles on the site after 2200 hours or before 0800 hours Litter pickers will be present from 0900 to 0100 hours Lighting will be necessary for public safety & crime prevention but will be kept to a sensible level

#### e) Protection of Children from Harm

Children on site will require adult supervision at all times Children will not be permitted on site after 2100 hours Plenty of non alcoholic refreshements will be available on site Parents will be advised that it is an offence to be intoxicated and in charge of children under 7 years of age

#### Annex 3

#### **Responsible Authority Conditions**

Thames Valley Police:

- 1) The management of the premises shall devise and implement a policy to monitor and control the access and exit of young persons possibly underage from the premises.
- An entry, closure and dispersal policy for controlling the opening and closing of the premises and the departure of customers at the conclusion of licensed activities must be put in place and must be actively operated.
- During trading hours, a nominated individual with appropriate training and experience can be identified as being responsible for each particular bar area, the person will be a Personal Licence Holder.

#### Health & Safety:

1. At all events to which there is an element of 'employment' a current certificate of electrical safety in a form prescribed in the Institute of Electrical Engineers Wiring Regulations, signed by a competent person, should be obtained for the electrical installation in connection with the licence (fixed and temporary structures).

2. At all events to which there is an element of 'employment' a current certificate of gas safety signed by a person competent under CORGI, should be obtained for the gas installation in connection with the licence (for fixed and temporary supplies).

3. Arrangements should be made for the first aid treatment of Members of the public who are attending events in connection with your licence.

4. A current certificate showing that the marquee has been constructed safety, signed by a competent person, should be submitted for

#### the structures erected in connection with your licence.

A current certificate showing that the marguee and all hangings used in the marguee and any soft furnishings used are of durably flame retarded fabric or inherently flame-retarded fabric and a certificate should be provided, signed by a competent person, for all such structures erected in connection with your licence.

Thames Valley Police following minor variation application June 2010:

1. All incidents which impact on any of the four licensing objectives shall be recorded in a register kept at the premises for this purpose. The names of the person recording the information and those members of staff who deal with the incident shall also be recorded. Where known, any offenders name shall also be recorded.

2. Notices advertising the Challenge 25 policy shall be displayed in prominent positions on the premises.

3. The Premises Licence Holder shall ensure that a system is in place, and is used to prevent any customer who attempts to purchase alcohol and who appears to the staff member to be under the age of 25 years without having first provided identification. Only a valid British driver's licence showing a photograph of the person, a valid passport or proof of age card showing the "Pass" hologram are to be accepted as identification.

4. The Premise Licence holder shall risk assess the event in order to provide an adequate number of Security Industry Authority (SIA) licensed door supervisors, (at a minimum ration of 1 to 100 customers), must be provided at the premises after 19:00 hrs and until the premises are closed and the last customer has left the premises, whenever regulated entertainment takes place.

5. The Premise Licence holder shall keep and maintain a register of door supervisors. The register will show the following details:

- a) the name, home address and registration number of all door supervisors working at the premises.
- b) SIA registration number.
- c) date and time that the door supervisor commenced duty, countersigned by the Designated Premises Supervisor or Duty Manager.
- d) Any incident of crime and disorder, or concerning children must be recorded giving names
- of the door supervisors involved.
- e) date and time the door supervisor finished work, countersigned by the
- Designated Premises Supervisor or Duty Manager.

f) The door supervisor register must be kept at the licensed premises and be available for inspection by Thames Valley Police or an authorised officer from Wokingham Borough Council and shall be retained for period of six months from the date of the event.

6. The Premises Licence holder shall ensure that all Door Supervisors whilst employed at the premises shall wear 'High Visibility' arm bands to incorporate displaying their SIA badges.

7. The Premises Licence Holder shall ensure staff receive basic training in relation to acceptable documentation for proof of age, not serving alcohol to a person who is drunk etc. in respect of the Four Licensing Objectives contained within the Licensing Act 2003 for those authorised to sell alcohol. Written proof of training shall be recorded and maintained for a period of 12 months.

8. The Premises Licence holder shall prepare an Event Management Plan for each event, setting out how the event will be managed and the precautions which have been taken to cater for all reasonably foreseeable contingencies, and which will demonstrate the procedures, roles and specific responsibilities of his management team, security and associated personnel. The finalised version of such a plan must be submitted to and approved by the Licensing Authority not later than 2 months prior to commencement of the events.

11. The maximum number of patrons permitted entry at any one time during the sale of alcohol or when regulated entertainment is taking place shall not exceed 500 persons,

12. Whenever regulated entertainment is taking place, between 19:00hrs and closing time and until the last customer has left the premises, Wednesday to Sunday inclusive, barriers shall be erected in order to safely regulate customers entering and leaving the premises.

An application for minor variation can only be accepted if "the overall test is whether the proposed variation could impact adversely on any of the four licensing objectives". This appears to have been part of a general review of Henley Royal Regatta licenses instigated by the Licensing Authority. We are surprised that such a review has not involved the local community and ask you for evidence that local concerns have been taken into account. Given the history of concerns and criminal behaviour at Henley Royal Regatta, any removal of conditionality or change of conditions should be subject to intense scrutiny by the Responsible Authorities. Please provide me with the evidence that this scrutiny has occurred.

The involvement and concerns of the local community is the thrust of government legislation and should not be treated lightly. Whilst the legislation places a heavy burden on the Responsible Authorities, they exercise this burden as agents of the local community and the public at large, it would be an abrogation of that responsibility to use the minor variation process to remove voluntary conditions agreed with interested parties, the local community or neighbours.

We assume that this scrutiny will evidence that public safety, prevention of crime and disorder, public nuisance and the protection of children from harm have been properly considered by the Responsible Authorities.

This application seeks to increase the licensing for recorded music, dancing and alcohol to midnight on every night of Henley Royal Regatta and the provision of late night refreshment until 00.30. The application for minor variation upon which we were asked to comment did not include the license. Thank you for sending me a copy

We object to any licensable activities taking place after midnight. Henley Royal Regatta lasts for five days. It is important for the residents that a curfew exists from midnight as activity will start at daybreak, rowing, clearing up, deliveries and setting up which can be as early as five am
