Application for Review of Premises Licence

My name is Jonathan Peter Dray. I am employed by West Berkshire and Wokingham Environmental Health and Licensing Service as a Principal Environmental Health Officer within the Environmental Quality Team. I am a chartered member of the Chartered Institute of Environmental Health.

The Environmental Quality Team is the 'responsible authority' for 'The Prevention of Public Nuisance' licensing objective. I am applying for a review of the premises licence for Temple Island Meadow on the grounds that the licensing objective 'the Prevention of Public Nuisance' is not being met.

The licence relates to a three day event known as the Rewind Festival that takes place on the third weekend of August each year. The first event was held in 2009 under the Remenham Farm licence (PR0 258) and in each subsequent year under its own licence, reference PR0338. The following condition (no. 15) was applied to the new licence:

The sound level from amplified music, amplified speech or other amplified sound shall not exceed 65dB LAeq, measured over a 15 minute period between 11:00H and 23:00H at one metre from the façade of noise sensitive residential premises.

Environmental Health has monitored the event each year. In the first year, 2009, there were breaches of the noise limit applied by the relevant condition of the Remenham Farm licence reference PRO258. In 2010, the first event held under the new three day licence, Environmental Health witnessed no breaches of condition 15 however during 2011 and 2012 the noise limit was exceeded on a significant number of occasions.

In 2011 the breaches of condition 15 were reported to the Licensing Authority and the decision was made by the Licensing Authority to send a warning letter to the Licence Holder.

Informal discussion and email exchange took place with Michael Sugiura, noise consultant for the Rival Organisation well before the 2012 event. Discussion centred on the inability of management to control visiting sound engineers who take control of the mixing desk and override pre- agreed volume settings. It was suggested that the installation of an electronic sound limiting device would prevent this however this suggestion was rejected by the Rival Organisation. A copy of these emails and an email-sent to David Heartfield (Rival Organisation-Ltd) is submitted with this application.

In 2012 further breaches of conditions 15 were reported to the Licensing Authority. A copy of the report, entitled The West Berkshire and Wokingham, Environmental Health and Licensing Service *Acoustic Report*, is included with this application. This report sets out the results of monitoring that took place over the weekend of the festival by the Environmental Quality Team. It refers to complaints that were received and makes some initial draft recommendations.

The Remenham Farm Residents Association also commissioned noise monitoring during the 2012 and submitted a report entitled The Remenham Farm Residents' Association Summer Events 2012 Event Noise Compliance Report dated September 2012 and prepared by Three Spires Acoustics. This report includes the results of the monitoring carried out by Three Spires Acoustics during the Rewind Festival 2012 and is included with this application.

Both reports mentioned above identify significant repeated breaches of the noise limit imposed by conditions 15 of the Licence. It is my opinion that public nuisance has arisen as a result of the failure to comply with this condition and I am not confident that there will no recurrence of public nuisance during the planned event in August 2013.

Options

A number of options are available to members of the Licensing Sub Committee as follows:

- 1) To reject the need for a review of the licence
- 2) To issue a warning to the licence holder
- 3) To revoke the licence
- 4) To amend the conditions of a licence.

It should however be noted that:

- 1) The evidence submitted and the number of complaints received from local residents would indicate that to 'do nothing' is perhaps not an option
- 2) The licence holder has already received a written warning from the Licensing Authority following the 2011 event and failed to respond effectively for the 2012 event

It is my intention to submit a list of amended conditions for consideration by the Licensing Subcommittee should members be minded to amend the conditions of the licence. This list will be submitted at a later date, but before the hearing, after consultation with the Licence Holder and the Remenham Farm Residents' Association.

I am content with your summary reflects the key points discussed.


The test on Friday should also check the effectiveness of radio comms between mixer and Remenham as I understand that line of sight and weather can affect quality.

Thank you for coming in to the office today – it was good to see you. I just thought I would summarise our discussions as follows

I will write to David Heartfield to outline what we discussed including the following:

- 1) -How will-'guest'-sound-engineers at the mixing desk-be compelled to comply with agreed noise limits? e.g. Can something be added to contracts with the various artistes to ensure they comply with instructions from the Rival Organisations sound engineer (Bunny).
- 2) Need for somebody from Rival to have overall control of mixing desk
- 3) Consider installing electronic noise limiter that cannot be overridden.



- 4) How will communications between the monitoring stations and mixing desk be improved? Possible use of radio instead of text messages for example so response is more immediate and senior managers on site can monitor what is going on.
- 5) Mechanism to be put in place to escalate if no appropriate response from the mixing desk
- 6) Request details of all noise sources on site not just the main stage to be included in noise management strategy

Request up to date copy of site plan when it is ready.

8) Appointed noise consultant to attend sound tests on the Friday – forecast for weather conditions / predicted wind direction over the weekend to be taken into account.

. 9) JD to offer to attend pre-event meeting at Rival HQ

- 10) Agree with David Heartfield's suggestion that morning site meetings to discuss noise issues should be reinstated.
- 11) If appointed Mike S will make contact with residents to agree access to monitoring locations. Possibly agree 'proxy' noise limit at boundary with Old School House to facilitate monitoring.

I think this summarises most of what we agreed but if there is anything else please let me know

Good afternoon David

Just to update you following my meeting this morning.

The main outcome is the following list of ideas / suggestions:

- Organisers to look at ways of imposing better control over the bands' own sound engineers who
 take over the mixing desk by perhaps:
 - Imposing contractual controls over visiting sound engineers, to ensure that they adhere to pre- set limits.
 - Ensuring that Rival's own sound engineers are given the authority / confidence to overrule visiting sound engineers if required
 - the installation of a secure electronic noise limiting device.
- Organisers to look at ways of improving communications between monitoring locations and mixing desk by:
 - Use of radios instead of text messages. (If open channel is used senior management would perhaps have the opportunity to monitor what is going on).
 - Instructing the appointed noise consultant to escalate to David Heartfiled or other senior person if there is inadequate response from mixing desk.
 - Testing communications during the Friday sound check session to ensure that there are no 'distance' or 'line of sight' issues.
 - Re-establish morning briefing session (as you suggested) and ensure that representatives from production team and mixer desk are present
- 3) Appointed noise consultant to:
 - Concentrate resources on nearest noise sensitive receptors and to make contact with residents to ensure access to monitoring locations.
 - Consider establishing 'proxy' noise limit at site boundary with Old School House to facilitate monitoring
 - Not to get embroiled in 'Noise at Work' issues during event
 - Obtain list of all potential noise sources including equipment and machinery (i.e. not just the main stage) and include consideration of these in updated noise management strategy
 - Attend sound test session on the Friday evening and use opportunity to test lines of communication.
 - Monitoring strategy for each day to take into account the weather forecast—in particular the predicted wind direction over the weekend
 - Maintain some capacity to respond to complaints from Wycombe DC or South Ox DC if required
 - Provide as a minimum continuous monitoring and feedback capacity for duration of performances on the main stage

I hope you find these suggestions useful. I would be happy to attend a meeting to discuss this year's event if it would be helpful but I would prefer to do this away from the SAG meeting if at all possible.

Issues not discussed t — in the past we have received complaints about 'setting up' noise and at a recent meeting with the residents' association (mainly to discuss Regatta) they asked specifically if we could encourage the use of 'white noise' reversing alarms rather than the older bleeping reversing alarms. There was also concern expressed about noise from generators, particularly those left on overnight. I am not convinced that this is a problem with Rewind but it is worth taking into account when planning the site layout.

Finally - would you be able to send over a copy of the 2012 site layout plan when it is ready?

I have consulted Colin Pattenden of CP Sound concerning a sound limiter/anti-volume control for the event.

The music noise level can be set to a maximum without changing the quality of the music produced by the main PA line array system.

A mobile limiter system comprises a Sentry with display plus a display for each of the mixer desks. I think there are two mixers at Rewind Henley but will have to check if there is a backup mixer.

Type AT-1 controllers, each one linked to a mixer desk

XLR leads connecting each mixer to each AT-1 controller.

A microphone to the Sentry on a tall stand.

A modification to a Formula Sound Sentry & AT-1 A-weighted levels as they are not designed/manufacured to record LAeq (dB(A) only).

Estimated cost is £4k (assuming 3 mixers) excluding site set up costs. This cost would be less if no. of mixers are less.

Before I propose this to the Organisers have you mentioned a limiter in your letter following our recent meeting and would you therefore be looking for this in the Rewind the 80s Henley 2012 Noise Management Plan.

Thanks for your comments. I'll forward to David Heartfield.

A noise limiter is not accepted by the Organisers.

There is no change to the position of the stage from last year's position.

Wind conditions can affect sound propagation over long distances, however these effects are only of significance at distances of greater than 0.5km.

The sound level at a receiving position at a long distance from the sorce will not generally follow the normal inverse square law with distance (attenuation at6dB per doubling of distance). It will tend to fluctuate with time.

We are not proposing to have a weather station but observations will be done.

I will ask David about your comment in JD5. 'getting guest artiste engineers to sign something to say they have received and agreed to instructions'

I'll revert to you as soon as I have the final plan.



 - Details of any works or arrangements which are considered necessary, desirable or good practice to reduce off-site sound levels (e.g. orientation of main stage, traffic routes etc)
 - 10) Details of management arrangements including who the noise team report to and liaison with PA engineers and band engineers.
 - Consideration of incidental noise sources and their management e.g noise arising from setting up and dismantling activity, fairground, traders etc.
 - 12) Details of Communications
 - Between noise team staff, organiser and PA contractor a)
 - b) Between noise team and local authority
 - Between event and public to include details of pre-publicised complaint hotline
- (18) Control of Litter
 - The Licence Holder will ensure, as far as is reasonably practicable, that litter arising from each event is collected and disposed of in an 1) appropriate manner
 - Litter bins shall be provided at or near the exits to the licensed premises including the exits nearest to the river tow path
 - Litter bins shall be provided for the use of boats moored at designated moorings along the boundary to the licensed premises.
 - The litter bins shall be emptied at regular intervals to prevent over-flowing

Conditions consistent with the Operating Schedule:

- (19)A written Event Safety Plan and Risk Assessment will be produced.
- Joint briefings to be held between the Police, Emergency services, stewards, organisers and Local Authority Officers. (20)
- (21)The event will have stewards on hand to deal with potential crime and disorder issues. A Stewarding Plan will be provided.
- (22) SIA registered Door Supervisors will be used on the gates, bars and for the Rapid Response Teams. They will have their badge of accreditation on display.
- Festival attendees will not be permitted to take food and alcohol into the arena. (23)
- Any person deemed to be intoxicated will not be served alcohol. Bar Managers will monitor alcohol sales closely. No persons under 18 will (24)be served alcohol, and documented proof of age will be requested by bar staff when in doubt.
- All structures within the event arena will have a safe capacity calculation conducted and at no time will those numbers be exceeded. All (25)structures will be stewarded with a robust system of counting in and out in place.
- A written Emergency Procedure Plan will be produced and appended to the Event Safety Plan. A chain of command will be established (26)with an organisational structure. Key people will be in radio contact throughout the event with a mobile telephone back up. Regular meetings will be held through the event duration in order to update on current operating conditions.
- A Fire Risk Assessment will be contained within the Event Risk Assessment. All fire fighting equipment will be tested and in date. (27)
- (28)Fire procedures, including designated fire emergency routes for the statutory services to attend all parts of the site, will be implemented prior to the event gates opening. The full fire procedures will be discussed and agreed with the Fire Authority.
- Caterers and traders will be sent fire safety precaution advice prior to the festival. All caters and traders will be requested to bring at least (29)one operational 5kg dry powder extinguisher and light duty fire blanket, which will be inspected prior to the festival's start. All catering units that are grouped together will have a firebreak of 2.5 metres to the next structure.
- All structures will have suitable and sufficient fire extinguishers, which will be tested and operational. All equipment including generators (30)and lighting tower will be equipped with appropriate fire fighting equipment.
- The Event Organisers and Event Safety Officer will take all appropriate measures to ensure the competence of contractors on site. Risk (31)Assessments to be collected and collated.
- All copies of appropriate documentation along with the Event Safety Plan and Risk Assessment will be secured in the Production Porta (32)Cabin.
- A Stewarding Plan will be drawn up in consultation with the Police. A chain of command will be established and stewards will be in radio (33)communication throughout the event.
- All fireworks will be stored in appropriate containers away from public area and the public highway. (34)




