

I would like to suggest that the following matter is reviewed:

What reliable procedures exist to ensure that single persons (elderly, widowed, disabled), do not "fall through the net" if and when they become ill or require care or emergency services, whilst located at their (unsupervised) homes?

If they have a partner (wife or children, or local relatives or friends) they may be spotted as needing help, by virtue of being regularly seen, or by their strange behaviour being noticed. However, if they fall ill alone or cannot call for help, or do not even realise that they may need help (eg. because of an onset of dementia or by an accident) who is there to recognise their absence or to call for help. What options could we consider? Once they are "on the books" as needing help the social/care services would regularly check them, but initial needs could be missed until the problem has been noticed and recorded.

With the ongoing increase in divorce and family breakups – even in previously long lasting marriages - there could be many such persons in this "needy" singles category. I do not know how many single/elderly/disabled people there are in Wokingham Borough – that would be a useful set of figures for us to start with.

I think it could be useful to consider this as a subject for Scrutiny, in order to ensure that our Health and Wellbeing program recognises as many categories of need as possible.

Our conformance to the Health & Wellbeing program.

Pro-active recognition of possible issues, not just reactive.

Not responding quickly to a major health need category could have serious consequences, both for the person and for the local H&W authority.

Regular brief checks of vulnerable persons, on a routine "round robin" basis (whether by telephone call or visits or other methods, not just when they have actually become ill) can sometimes be cheaper than expensive treatment later.

Timescales & costs are, of course, significant to the chosen methods of checking and what is being checked. Potential Alzheimers candidates could be checked on a less urgent time frequency, whereas those who are not ill but subject to falling/accidents/burning or collapsing etc should be checked much more regularly. Discussion and ideas needed here to minimise costs and increase effectiveness.

Are there any specific aspects of the issue you would like scrutiny to focus upon or supporting evidence?

The increase in single persons, either by reason of divorce or separation, or a partners death or adult offspring living remote to the vulnerable person. Numbers and "profiles" are needed so that we can establish the potential scale of the matter.

Identifying various methods of maintaining simple but effective contact to ensure the protection of vulnerable persons.

Evidence would seem to be the increasing need for smaller homes and flats for single persons, or older couples downsizing (where one of the older couples could pass on in the medium term – awareness of their age and health would be useful on their occupation of the smaller dwelling).

The standard installation of low cost communication devices when building these smaller/older-person homes could assist the checking process in terms of practicality and cost. Knowledge of such devices and costs would be useful.

An example of such a simple device could be some type of multi-button or numbered keypad in their home, where for

example the resident is asked to enter a fixed number or code each morning say between 0700 and 1500, to confirm their presence and fitness. Non-contact or entering a wrong code or doing it at night could indicate a problem. The receiving devices at the Council end could be the equivalent of an auto telephone switchboard with attached printer that outputs the caller's ID with name/address and entered code, plus the date and time of day of every receipt, onto a serial timed list that is then "eyeball scanned" by a care person. Absence of timely and accurate entry could indicate that the person has had an accident or is ill - whereas a regularly wrong code or wrong time could indicate the onset of dementia/Alzheimers. A brief phone call or visit could then be made to check for safety. Hopefully there should not be too many to check for each hour of the planned list. Logically, I imagine we could assume the majority of persons would make contact every day correctly, and not require further local checking, but the few that fail and need that extra check still need to be recognized and dealt with promptly.

We should identify which organizations/people are most likely to know the scale and numbers involved in this – and then obtain some guidance/info from them.

Details of possible options (devices, costs, staffing, and implementation aspects) to achieve this improved level of checking of vulnerable persons.

Also, if possible, what would be the likely consequences of not doing such a Health and Wellbeing check – especially if the likelihood of such dementia/alzheimers need continues to increase.
