

**TITLE** Update on 2013/14 transfer groups

**FOR CONSIDERATION BY** Admissions Forum on 17 July 2013

### **SUMMARY**

The purpose of this report is to present updated information on the three transfer groups – entry to primary; primary to secondary transfer and transfer to year 3 junior schools.

This report includes information on changes made as a result of the central co-ordination of applications made to Charvil Primary School made on behalf of The Piggott School after the primary offer day of 16 April 2013.

### **SUPPORTING INFORMATION**

This report should be read in conjunction with the Annual Report to the Office of the School's Adjudicator which included general information about each cohort.

Enclosed with this report is allocation information for the three cohorts showing how places were allocated at schools against the school admission criteria together with appeal statements which gives information on how many children did not receive an offer of a preferred school place against the admission criteria who then formed the school waiting list pending confirmation from parents on their acceptance forms indicating that they wish to remain on school waiting lists.

#### **Transfer to secondary update**

Places are currently available at Wokingham borough secondary schools as follows:

The Emmbrook	54 places	
The Forest	2 places	
Oakbank	19 places	<b>Total: 195 places</b>

School waiting lists have reduced as follows:

The Holt – 16; Maiden Erlegh - 120 (includes 15 children living in the designated area – the last child living in the designated area lives 1.261 miles from the school); The Piggott - 40 (school is over-allocated due to successful appeals by 16); St Crispin's – 7 and Waingels College – 3.

There have been 89 late applications. 4 children are currently without a school place after their parents have refused the schools offered and whilst they explore other options.

Appeals update – 4 appeals were heard for Holt, all refused; 24 appeals were heard for Maiden Erlegh, 3 allowed and 21 refused; 17 appeals were heard by the Oxford Diocese all were allowed; 1 appeal was heard and refused for St Crispin's and Waingels College respectively.

School waiting lists are as follows: Aldryngton Primary – 51 children including 1 late designated area; Bearwood Primary – 6; Beechwood Primary – 4; Crazies Hill CE Primary – 4; Earley St Peter's CE Aided Primary – 2, Emmbrook Infant – 16; Finchampstead CE Aided Primary – 3, Gorse Ride Infant – 4 including 2 late designated area; Hatch Ride Primary – 6, Hawkedon Primary – 14; Hawthorns Primary – 22 including 1 late designated area and 6 siblings living outside designated area; Hillside Primary – 19 including 1 late designated area; Keep Hatch Primary – 16 including 1 late designated area and 1 sibling living outside designated area; Loddon Primary – 9 including 1 late designated area; Nine Mile Ride Primary – 22, Polehampton CE Infant – 6; Radstock – 60 including 8 designated area and 6 siblings living outside designated area; Sonning CE Aided Primary – 5; South Lake Primary – 6; St Nicholas CE Aided Primary – 1; St Teresa's Catholic Primary – 22; Coombes CE Primary – 20 including 4 late designated area; Walter Infant 33 including 2 late designated area and 10 siblings living outside designated area; Wescott Infant – 37 including 9 designated area and 5 siblings living outside designated area and Winnersh Primary – 1.

The following schools are full but do not currently have a waiting list: All Saint's CE Aided Primary, Lambs Lane Primary, Oaklands Infant, Robert Piggott CE Infant; Whiteknights Primary and Woodley CE Primary.

Applications were sent to parent who expressed interest on 1 May 2013, with an application deadline of 20 May and offer letters were sent out on 4 June. There were 29 'on time' applications (received by the deadline) and one 'late' application received prior to offer day and therefore the school could offer a place to all applicants regardless of oversubscription criteria.

Parents were asked on acceptance to identify which school waiting lists they wanted their child to remain on in order that we could identify the order of preference.

Schools mostly affected by the allocation were St Dominic Savio Catholic Primary School and Willow Bank Infant Schools which were the schools where Charvil residents had been allocated as an alternative school. There was also a significant reduction in the waiting list of Polehampton CE Infant, Robert Piggott CE Infant, St Nicholas CE Primary, Woodley schools and creation of spaces at The Colleton Primary.

Schools were advised the number of children allocated, whose parents had subsequently applied and all schools affected have been advised of the children who have come of the school allocation lists, subsequent allocation from school waiting lists where appropriate and Piggott have been advised of the children allocated and accepted.

Discussion is currently ongoing with Glyn Learning Foundation to agree dates for the application round for the Woosehill and Winnersh schools sites (Windmill Primary School and Wheatfield Primary School). Inevitably there will be some late changes to school allocations in the Wokingham and Winnersh area as places are accepted.

Appeals to date (due to conclude on 12 July): Aldryngton - 2 heard both refused; Bearwood – 1 allowed; Beechwood – 1 allowed; Coombes – 2 both allowed; Hillside – 1 refused; Keep Hatch – 2 refused; Nine Mile Ride – 2 refused; Radstock – 4 refused; South Lake – 3 refused, St Teresa's – 4 refused. Pending appeals are for Hawthorns – 3; Walter – 9 and Wescott – 7.

There have been 81 late applications and there are currently 7 children that are currently without a school place as their parents have refused the school offered.

The Bulmershe	240	All applicants who expressed a preference and where no higher ranked preference could be offered were allocated places. 40 pupils, whose applications for other schools were unsuccessful, were allocated to the school as the nearest school with places.
The Emmbrook	210	All applicants who expressed a preference and where no higher ranked preference could be offered were allocated places. 9 pupils, whose applications for other schools were unsuccessful, were allocated to the school as the nearest school with places.
The Forest	200	The school was fully allocated with applicants who qualified under oversubscription criteria A to F plus 3 pupils based on radial distance in criterion G. The last pupil allocated under criterion G lives 1.121 miles from the school according to the computerised mapping system used by the council's School Admissions Team. There were insufficient places for the remaining 28 applicants in criterion G. These applicants have been provisionally placed on a waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.
The Holt	200	The Governing Body at The Holt School commissioned Wokingham Borough Council to rank applications on its behalf against the school's oversubscription criteria. The school was fully allocated with applicants who qualified under oversubscription criteria A to D plus 3 applicants based on radial distance in criterion E. The last pupil allocated under criterion E lived a radial distance of 3.639 miles from The Holt School according to the computerised mapping system used by the council's School Admissions Team and was allocated in accordance with the school's multiple birth policy. There were insufficient places for the remaining 1 applicant in criterion E; 33 applicants in criterion F and 8 in criterion G. These applicants have been provisionally placed on the waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.
Maiden Erlegh	278	The Governing Body at Maiden Erlegh School commissioned Wokingham Borough Council to rank applications on its behalf against the school's oversubscription criteria. The school was fully allocated with applicants who qualified under oversubscription criteria A to B plus 159 applicants based on radial distance in criterion C. The last pupil allocated under criterion C lives 1.030 miles from the school according to the computerised mapping system used by the council's School Admissions Team. There were insufficient places for the remaining 31 applicants in criterion C; 10 applicants in criterion D and 112 in criterion E. These applicants have been provisionally placed on the waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.

Oakbank	120	<p>The Governing Body ranked the applications as follows: Children with Statements of Special Educational Needs followed by Founder children and siblings. The remaining places were prioritised based on the percentages allocated to each sector. Sector 1 (Shinfield) has 30% of the places which equates to 30 children, sector 2 (Spencer's Wood and Swallowfield) has 40% of the places which equates to 41 children and sector 3 (Three Mile Cross and Grazeley) has 30 percent of the places which equates to 30 children. Sectors 2 and 3 are not oversubscribed, so all of the children living in those sectors can be prioritised (49 children), and the remaining 52 places could be prioritised to sector 1, which is oversubscribed and has been ranked by distance from the school. If there are any remaining places available after these 3 sectors have been allocated they could be offered to applicants living outside of the 4 mile sector, selected by lottery if there are not enough remaining places.</p> <p>After co-ordination, all applicants who expressed a preference and where no higher ranked preference could be offered were allocated places. 3 pupils, whose applications for other schools were unsuccessful, are allocated to the school as the nearest school with places.</p>
The Piggott	180	<p>The Governing Body ranked the applications and after co-ordination, the school was fully allocated with applicants who qualified under oversubscription criteria A to C plus 20 applicants in criterion D. The last pupil allocated under criterion D lives 4.091 miles from the school according to the computerised mapping system used by the council's School Admissions Team. There were insufficient places for the remaining 106 applicants (10 in criterion D, 15 in criterion E, 23 in criterion F and 58 in criterion G). These applicants have been provisionally placed on the waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.</p>
St Crispin's	189	<p>The school was fully allocated with applicants who qualified under oversubscription criteria A to E. The last pupil was allocated under Criterion E and lives 6.368 miles from the school according to the computerised mapping system used by the council's School Admissions Team. There were insufficient places for the 39 applicants considered in criterion G. These applicants have been provisionally placed on the waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.</p>
Waingels College	240	<p>The school was fully allocated with applicants who qualified under oversubscription criteria A to F plus 33 pupils based on radial distance in criterion G. The last pupil allocated under criterion G lives 1.860 miles from the school according to the computerised mapping system used by the council's School Admissions Team. There were insufficient places for the remaining 34 applicants in criterion G. These applicants have been provisionally placed on a waiting list pending confirmation from parents that they wish to remain on the waiting list for the school.</p>

Children with statements of special educational needs that named a school in the statement were admitted to the school that is named.

**Oversubscription Criteria:**

- A Priority will be given to looked-after children and children who were looked after, but ceased to be so because they were adopted or became subject to a residence order or special guardianship order (previously looked-after children).

A 'looked after child' is a child who is (a) in the care of a local authority or (b) being provided with accommodation by a local authority in the exercise of their social services functions (see definition in section 22(1) of the Children Act 1989). Previous 'looked after children' include those children under the terms of the Adoption and Children Act 2002 (section 46 relating to adoption orders), Children Act 1989, section 8 which defines a 'residence order' as an order settling the arrangements to be made as to the person with whom the child is to live and section 14A which defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians).

- B Children who have a serious medical, physical or psychological condition for admission to a particular school. This must be supported by written evidence, relating specifically to the school you are applying to under this criterion, from an independent professional aware of the child's case (e.g. doctor, hospital consultant or psychologist) which must explain the reason why the school in question is the most suitable and the difficulties caused if the child had to attend another school.

- C Children whose permanent home address is in the school's designated area and who have a brother or sister, half brother or sister, adopted brother or sister, step brother or step sister or the child of parent/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling and who will be at the school when the child will enter the school.

- D Children whose permanent home address is in the school's designated area

- E Children who have a brother or sister, half brother or sister, adopted brother or sister, step brother or step sister or the child of parent/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling and who will be at the school when the child will enter the school

- F Children whose parents have a preference for single sex education

- G Any other children

If the school does not have sufficient places for all children in any category A to G, places will then be allocated on the basis of the radial distance between the home and the school (straight line measurement). All measurements are undertaken consistently using the computerised mapping system used by the council's School Admissions Team and the distance will be measured as a straight line between the Land and Property Gazetteer address points for the respective home address and school. Living in the designated area does not guarantee a school place as there may be more applications from parents living in the designated area than places available. A separate tiebreaker is in place for applicants in categories C and D for The Forest School where priority is given to the applicant whose permanent home address is the shortest combined radial distance to The Forest School and The Holt School.

The guide will also provide additional notes to the above oversubscription criteria.

Previous ‘looked after children’ include those children under the terms of the Adoption and Children Act 2002 (section 46 relating to adoption orders), Children Act 1989, section 8 which defines a ‘residence order’ as an order settling the arrangements to be made as to the person with whom the child is to live and section 14A which defines a ‘special guardianship order’ as an order appointing one or more individuals to a child’s special guardian (or special guardians).

- B Children who have a serious medical, physical or psychological condition for admission to a particular school. If the school does not have sufficient places for all children in any criteria A to H, places will then be allocated on the basis of the radial distance between the home and the school (straight line measurement). All measurements are undertaken consistently, using a computerised mapping system and the distance will be measured as a straight line between the Land and Property Gazetteer address points for the respective home address and school. Living in the designated area does not guarantee a school place as there may be more applications from parents living in the designated area than places available. Children with statements of special educational needs that name a school in the statement are required to be admitted to the school that is named.

### KEY TO HOW PLACES WERE ALLOCATED IN COMMUNITY AND VOLUNTARY CONTROLLED SCHOOLS

The following oversubscription criteria, in order of priority, were applied when a community or voluntary controlled school received more preferences than places available:

- A Priority will be given to relevant Looked after Children or children who were looked after, but ceased to be so because they were adopted or became subject to a residence order or special guardianship order.
- B Children who have serious medical, physical or psychological grounds for admission to a particular school.
- C Children whose permanent home address is in the school's designated area and who have a brother or sister, half brother or sister, adopted brother or sister, step brother or sister or the child of the parent/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling and who will be at the school when the applicant would enter the school.
- D Children whose permanent home address is in the school's designated area
- E Children who have a brother or sister, half brother or sister, adopted brother or sister, step brother or sister or the child of the parent/carer's partner where the child for whom the school place is sought is living in the same family unit at the same address as that sibling and who will be at the school when the applicant would enter the school
- F Children whose parents choose the school on denominational grounds (Voluntary Controlled schools only)
- G Any other applications

*For both community and voluntary controlled schools - all children with statements of special educational needs that named a school in the statement were admitted to the school that was named*

If the school does not have sufficient places for children in any category, places will then be allocated on the basis of the radial distance using the local authority's computerised mapping system and the distance will be measured as a straight line between the Land and Property Gazetteer address points for the respective home address and school.
