LOCAL AREA AGREEMENT 2008-11 REFRESH DOCUMENT

The Committee considered a recommendation from the Executive to accept and adopt the first annual refresh document of the Local Area Agreement 2008-11 containing refreshed targets which had been negotiated between Officers and/or lead agencies such as Thames Valley Police and Berkshire West Primary Care Trust and the Government Office of the South East.

Members noted that since the agenda had been printed further negotiations had taken place and feedback from Government Offices had been received and therefore a revised Appendix B, including amendments to certain targets, was tabled.

Councillor Bray queried which targets had changed from those that were agreed last May and was informed that a number had not been set last year because the data on which to establish baselines had been unavailable. The information was now available and therefore those targets could now be agreed.

RESOLVED: That the refreshed Local Area Agreement targets, as set out in the revised Appendix B to the report, be adopted for submission to the Government Office for the South East before the end of March 2009.

PURPOSE OF REPORT

To reduce the housing rents agreed at Council on 19 February 2009.

RECOMMENDATIONS

That the Committee agree that Council House dwelling rents be decreased from an average of 6.35% (approved 19 February 2009) to an average of 3.24% effective from April 2009.

SUPPORTING INFORMATION

Housing Revenue Account 2009/10

Consultation

In response to the economic downturn and after pressure from local councils, the Government announced that it would allow councils to reduce rent increases for 2009/10 without loss to their HRA. The amending determination (for the purposes of calculating the subsidy payments) has now been received.

The average actual rental increase per dwelling per week for Wokingham Borough Council tenants reduces to £2.56 (3.24%), from an increase of £5 (6.35%).

The total expected reduction in actual rental income to the 2009/10 HRA is £331K.

The guideline rent (used to calculate housing subsidy) decreases by £387K and therefore a reduction in the subsidy payment we make to the Government.

The cost of implementing the change can be met from the net benefit to the HRA.

WBC tenants will benefit as a result of lower rents from July 2009, backdated to April 2009. In addition Wokingham will not lose any funding available to carry out much needed repairs.

Corporate Implications

This exercise will be cost neutral with no additional cost to the general fund or HRA.

Reasons for Decision.

On 6 March 2009 Margaret Beckett suggested that council house rents could be halved from 6.2% to 3.1% due to the current economic climate. Wokingham Borough Council following consultation decided to take up the offer of additional financial support to

ensure WBC tenants receive the full benefit of a reduced rent. The Council's constitution requires the approval of the Housing Revenue Account budget by Council to enact the new Housing Subsidy arrangements for 2009/10.
