7.00		EXCLUSION OF THE PUBLIC The Sub-Committee may exclude the press and public from its consideration of this matter where it appears likely that confidential or exempt information will be disclosed in the course of this consideration.	
		The Chairman shall ask the Member, the Investigating Officer and the Legal Advisor to the Sub-Committee whether they wish to exclude the press and public from all or part of the hearing. If any of them so request, the Chairman shall ask them to put forward reasons for so doing and for ask for responses from the others, being mindful that guidance from Standards for England is that hearings should be held in public wherever possible. The Sub-Committee will then determine whether to exclude the press and public from all or part	

of the hearing.

Where the Sub-Committee does not resolve to exclude the press and public, the Agenda and any documents which have been withheld from the press and public in advance of the meeting shall then be made available to the press and public.
