#### **PURPOSE OF REPORT**

The Call-In process exists to ensure that key decisions are taken in line with agreed principles relating to, for example, openness, consultation and proportionality. This provides public confidence in the Council's decision making process.

#### **RECOMMENDATION**

The Committee is requested to:

- 1) consider the Call-In request relating to the Executive Member Decision on the Wokingham Borough-wide Off Street Car Parks Order 2021;
- 2) consider the Officer response to the Call-In (Agenda item 75);
- 3) having considered the evidence, determine whether to confirm the Executive Member decision or refer the matter back to the Executive Member for further consideration, with recommendations as appropriate.

# **SUMMARY OF REPORT**

In accordance with the Council's Constitution, five non-Executive Members of the Council have submitted a formal notice "calling-in" the Executive Member Decision relating to the Wokingham Borough-wide Off Street Car Parks Order 2021. The decision was taken on 16 December 2021.

The decision was taken by the Deputy Leader of the Council, standing in for the Executive Member for Highways and Transport. The decision was to:

- Instruct officers to proceed with the making of relevant Off-street Car Parks Traffic Regulation Orders;
- Instruct officers to write to all objectors and to advise them of this decision.

The report sets out details of the Council's Call-In procedure, the procedure to be followed at the meeting and the options available to the Committee following consideration of the evidence.

Agenda item 75 sets out the detailed Officer response to the Call-In.

#### **Background**

An Individual Executive Member Decision (IEMD) meeting was held on 16 December 2021 to consider the proposed Wokingham Borough-wide Off Street Car Parks Order 2021. The IEMD report stated that the Council needed to make changes to its existing Off-Street Borough Car Parks Order in line with the Borough-wide parking management improvement plan. The main purpose of these changes was stated as:

- Enabling the Council to enforce against increasing instances of anti-social behaviour in existing car parks;
- Providing a separate Order for existing and new Park and Ride car parks;
- Responding to resident requests for clarity on charging;
- Limiting the maximum stay permitted at California Crossroads car Park;
- Incorporating provisions enabling the Council to designate electric vehicle charging parking bays in any Off-Street Car Parks.

The IEMD report is appended to this report along with the Decision Record Sheet. The decision taken was to:

- Instruct officers to proceed with the making of relevant Off-street Car Parks Traffic Regulation Orders;
- Instruct officers to write to all objectors and to advise them of this decision.

## **Decision Making Principles**

Section 1.4.2 of the Constitution states that all decisions of the Council will be made in accordance with the following principles:

- a) proportionality (i.e. the action must be proportionate to the desired outcome);
- b) due consultation and the taking of professional advice from Officers;
- human rights will be respected and considered at an early stage in the decision making process;
- d) a presumption in favour of openness;
- e) clarity of aims and desired outcomes; and
- f) when decisions are taken by the Executive, details of the options which were taken into account and the reasons for the decision will be recorded.

#### **Call-In Details**

In line with the Council's Constitution, the Individual Executive Member Decision was called-in, on 23 December 2021, by Councillors Boyt, Bray, Conway, Doran and Jones.

The Call-In was submitted on the basis that:

"The decision has contravened Section 1.4.2 a), d) and e) of the Council's Constitution, insofar as it cannot be determined from the information provided, whether the action is proportionate to the desired outcome and 1.4.2 e) there is no clarity of aims and desired outcomes."

The detailed Call-In sheet is appended to the report (Annex 1).

Item 75 on the Agenda sets out the Officer response to the points made in the Call-In paper.

#### Call-In Procedure

The procedure to be followed at the Call-In meeting is as follows:

- The Overview and Scrutiny Committee Chairman explains the purpose and structure of the meeting;
- One of the five non-Executive Members who called-in the decision outlines the reasons for the Call-In;
- Witnesses can be called as necessary and can make a short presentation to the Committee;
- Members of the Committee can ask questions of the non-Executive Member and any witnesses;
- The relevant Executive Member (supported by Officers) responds to the points made in the Call-In;
- Witnesses can be called as necessary and can make a short presentation to the Committee:
- Members of the Committee can ask questions of the Executive Member, Officers and any witnesses;
- The Executive Member sums up the response to the Call-In;
- One of the five non-Executive Members sums up the Call-In;
- The Committee draws its conclusions and decides whether to confirm the Executive Member's decision or recommend that the Executive Member reconsiders (with appropriate recommendations).

The Overview and Scrutiny Management Committee cannot overturn the decision/s subject to Call-In. If the Committee has concerns, it can refer the decision back to the Executive or Executive Member for further consideration, with any recommendations the Committee has agreed. If the decisions are referred back, the Executive or Executive Member should carry out the reconsideration within 20 working days.

#### 1.4.2 Principles of Decision Making

All decisions of the Council will be made in accordance with the following principles:

- a) proportionality (i.e. the action must be proportionate to the desired outcome);
- b) due consultation and the taking of professional advice from Officers;
- c) human rights will be respected and considered at an early stage in the decision making process;
- d) a presumption in favour of openness;
- e) clarity of aims and desired outcomes and
- f) when decisions are taken by the Executive, details of the options which were taken into account and the reasons for the decision will be recorded.

#### Reason for Call-in:

The decision has contravened Section 1.4.2 a),d) and e) of the Council's constitution, insofar as it cannot be determined from the information provided, whether the action is proportionate to the desired outcome and 1.4.2 e) there is no clarity of aims and desired outcomes

The Officer Report states the following:

#### Changes to Operating Hours

The new Off-Street Car Parks Orders will enable the Council to take action against antisocial behaviour, misuse and vandalism of public car parks by extending the current, 10hour daily charging period to be 'At All Times' and car park operating hours to apply from Mon-Sun (including bank holidays).

This means that all car park users will be required to comply with parking regulations at all times and the Order will permit the Council to issue penalty charge notices to those vehicles in its use car parks as part of anti- social gatherings. These controls will be supported by CCTV and meet the recommendations for deterring such activity made by Thames Valley Police.

And the verbal explanation by the Lead Officer:

"As it stands now you can enter a car park and leave your vehicle and there is no record of your vehicle being there. You don't have to register it or get a ticket for it or anything. Under this new order we'll be able to do that in all car parks and that will deter ASB particularly; they won't want to register a vehicle as having been there"

- What are the recommendations made by Thames Valley Police? Are they
  proportionate to the problem? What happens where ASB is committed but (as is
  likely to be the case) the perpetrator does not register his/her vehicle?
- This implies that everyone using the car parks in the evening and on a Sunday will have to register their vehicle and check in and out. What evidence is there that perpetrators of anti-social behaviour will comply with this requirement? If they do not, how does this requirement assist with identifying them?
- How will this requirement impact on residents who use the car park and forget to check in? Will enforcement officers be active 24/7? What is included in the policy that would avoid innocent residents being fined simply for failing to display a ticket during times when there is no charge for using the car park? How are residents being informed of the change, which will require them to have a ticket at all times, when previously there was no requirement and people used to using the car park would not even look at the ticket machines overnight or on a Sunday?
- The supporting CCTV will help to deter ASB, but can it be used to prosecute offenders?

Name (nlease print)

 Members have been told variously that the CCTV cameras were installed due to theft of catalytic converters, to reduce emissions caused by queuing cars, and now to deter ASB. Section 1.4.2 d) states there should be a presumption of 'openness'. This is not apparent here.

# **PURPOSE OF REPORT (Inc Strategic Outcomes)**

This report seeks approval to conclude the Traffic Regulation Order process for a revision to the existing Off-Street Car Parks Order, following a review of responses received during the statutory objection period.

#### RECOMMENDATION

It is recommended that the Executive Member\* considers the objections received and the officers' responses thereto and;

- 1. Instructs officers to proceed with the making of relevant Off-street Car Parks Traffic Regulation Orders;
- 2. Instructs officers to write to all objectors and to advise them of this decision;

OR

3. Instructs officers to abandon the Order making process

#### SUMMARY OF REPORT

This report summarises the Objections received to the proposed Wokingham Boroughwide Off-Street Car Parks Order 2021.

These proposals were published on the Council's website, displayed within all car parks and published in a local newspaper for a period of 35 days, in accordance with statutory requirements.

All of the comments and objections received were recorded and officers' responses are provided in respect of each response received during the statutory objection period. These are summarised in Appendices A and B of this report.

\*Please note the Leader of the Council will stand-in for the Executive Member for Highways & Transport at this meeting.

#### **Background**

As part of its Borough-wide parking management improvement plan, Wokingham Borough Council needs to make changes to its current Off-Street Borough Car Parks Order. The primary purposes of these changes are to enable the Council to introduce parking controls which enable it to enforce against increasing instances of antisocial behaviour in existing car parks; to provide a separate Order for our existing and new Park & Ride car parks; to respond to resident requests for clarity in charging; to limit the maximum stay permitted at California Crossroads Car Park; and to take this opportunity to incorporate provisions that will enable the Council to designate electric vehicle charging parking bays in any Off-Street Car Parks.

The Council is also taking this opportunity to update and amend the Articles\* of the 2017 and 2018 Orders, absorbing the remaining provisions from those Orders that have not been incorporated in the new Borough Park & Ride Sites Order. \*Articles are separate and distinct parts of a written Order that is divided into sections containing a series of rules and stipulations that are each designated as an article.

## **Changes to Car Park Management**

Changes to the car parks Order are necessary to remove a number of off-street car parks that are no longer operated by the Council. The car parks being removed are Elms Road, Wokingham Multi-Storey; The Paddocks Car Park, Wokingham; and Wellington House Car Park, Wokingham.

The Order will create a new, separate Order for two new Park & Ride Car Parks at Coppid Beech and Thames Valley Park, incorporate the existing Mereoak Park & Ride Car Park and transfer Winnersh Triangle Park & Ride from the current Off-Street Parking Order.

The Council will also implement a maximum vehicle height restriction of 2.1 metres in Carnival Multi-storey; Shute End; Easthampstead Road East/West; Lytham Road East/West; and Station Road Car Parks.

## **Changes to Operating Hours**

The new Off-street Car Parks Orders will enable the Council to take action against antisocial behaviour, misuse and vandalism of public car parks by extending the current, 10hour daily charging period to be 'At All Times' and car park operating hours to apply from Mon-Sun (including bank holidays).

This means that all car park users will be required to comply with parking regulations at all times and the Order will permit the Council to issue penalty charge notices to those vehicles in its use car parks as part of anti-social gatherings. These controls will be supported by CCTV and meet the recommendations for deterring such activity made by Thames Valley Police.

#### **Changes to Off-street Parking Costs**

Although the charging periods will change, for example the single '0-2hrs' period will change to two periods of 'Up to 1 hour' and '1-2hrs', this Order will make no change to existing parking costs. The cost of parking will therefore remain the same for all customers across all operational hours, in all car parks.

The Order simplifies information about how much customers will need to pay for their selected parking periods by placing each time period into a 'parking band' that customers

can see clearly on signs displayed within each car park when. Alongside this change, an improved method of payment for customers is being rolled out in all car parks, with a 'check in/check out system' which means that customers can elect to stay for as long as they wish after checking in without fear of a penalty charge, as well as paying only for the time they have parked, instead of purchasing a longer period than is necessary.

This will support local businesses, enabling customers to shop, socialise and benefit for longer periods, whilst being fairer to customers and removing the need to display a ticket within the vehicle. Any future changes to parking costs that do become necessary will be determined by elected members in the same way that they currently are and published by a Notice of Variation to this Order.

# **Introduction of New Car Parking Controls**

The Off-street Car Parks Order will also allow the Council to support leisure users by introducing a new 15-minute initial parking period, without charge at Dinton Pastures Country Park Activity Centre Car Park, Hurst and a new 30-minute free visitor parking at the Council offices in Shute End (Mondays to Fridays 6am to 6pm). Drivers must check in using one of the machines nearby and display a free ticket in their vehicle.

As part of the regeneration of California Cross and to support the local economy, the Order will introduce a new, time-restricted parking period at the off-street California Crossroads Car Park of 1 hour maximum stay, with no return within 2 hours. This will improve turnover and space availability within the car park for customers.

To support the new Coppid Beech Park & Ride site we will introduce waiting and loading restrictions on a length of Oak Avenue, Wokingham and the Coppid Beech Park and Ride terminus road.

#### **Business Case (including Analysis of Issues)**

There is no requirement for a Business Case in support of these proposals. However, the benefits to be gained by the Council from making these changes include:

- A simplified and improved legislative basis upon which to manage its off-street car parks:
- An effective deterrence basis to deal with instances of antisocial behaviour, misuse and vandalism;
- Better car parking services for customers, greater flexibility in parking duration;
   and
- Reduced likelihood of penalty charges for overstaying in car parks.

A number of clarifications were sought at the meeting by the Deputy Leader and the Executive Member for Highways and Transport, in addition to comments raised by a member of the public. A summary of these clarifications can be found below:

- One of the objections was a duplicate, and therefore there were 16 official objections to the proposal;
- The proposals would lead to car parks being operational all day, which would allow car parking management measures such as vehicle registration to be used to combat antisocial behaviour incidents;
- The proposals would not make any changes to existing car parking fees and charges.

#### Reason for Call-In

The five non-Executive Members allege that the decision has contravened the following sections of the Constitution:

- Section 1.4.2 a) proportionality (i.e. the action must be proportionate to the desired outcome);
- Section 1.4.2 d) a presumption in favour of openness;
- Section 1.4.2 e) clarity of aims and desired outcomes;

asserting that "it cannot be determined from the information provided, whether the action is proportionate to the desired outcome" and "there is no clarity of aims and desired outcomes"

#### Response to alleged contravention of the Constitution

The decision to approve the Wokingham Borough-Wide Off-Street Car Parks Order 2021 and the preceding formal public consultations were undertaken in accordance with the Council's Constitution and the statutory requirements for a Traffic Regulation Order. This is the same approach that the Council follows for all other Traffic Regulation Order changes and is an open and transparent process which allows the comments and objections of residents to be considered by the Council.

The IEMD report made clear that there were a number of reasons for bringing forward Wokingham Borough-Wide Off-Street Car Parks Order 2021, but that it was primarily about updating some out of date information in the previous order and separating our town centre car parks from the new Park and Ride sites. Alongside this we took the opportunity to introduce some additional measures which will improve our ability to address ASB within our car parks following our experiences during the Covid pandemic.

The IEMD sets out all of the reasons for making changes to the Off-Street TRO as part of its Borough-wide parking management improvement plan, summarised below:

- to enable the Council to introduce parking controls which enable it to enforce against increasing instances of antisocial behaviour in existing car parks;
- to provide a separate Order for our existing and new Park and Ride car parks;
- to respond to resident requests for clarity in charging;
- to limit the maximum stay permitted at California Crossroads Car Park;
- to incorporate provisions that will enable the Council to designate electric vehicle charging parking bays in any Off-Street Car Parks;
- to update and amend the Articles\* of the 2017 and 2018 Orders;
- to remove a number of off-street car parks that are no longer operated by the Council;
- to implement a maximum vehicle height restriction of 2.1 metres in the Carnival Multi-storey; Shute End; Easthampstead Road East/West; Lytham Road East/West; and Station Road Car Parks;
- to take action against misuse and vandalism of public car parks;
- to support leisure users by introducing a new 15-minute initial parking period, without charge at Dinton Pastures Country Park Activity Centre Car Park, Hurst and a new 30-minute free visitor parking at the Council offices in Shute End (Mondays to Fridays 6am to 6pm);
- to support the local economy, introducing a new, time-restricted parking period at the off-street California Crossroads Car Park of 1 hour maximum stay, with no return within 2 hours. This will improve turnover and space availability within the car park for customers;
- to support the new Coppid Beech Park and Ride site we will introduce waiting and loading restrictions on a length of Oak Avenue, Wokingham and the Coppid Beech Park and Ride terminus road.

#### **Responses to Individual Questions**

What are the recommendations made by Thames Valley Police? Are they proportionate to the problem? What happens where ASB is committed but (as is likely to be the case) the perpetrator does not register his/her vehicle?

Following a series of ASB episodes affecting our Carnival M/S car park, park and ride sites and other Council operated car parks during the COVID lockdown period, Thames Valley Police made recommendations to the Community Safety Team and Parking Services that time periods in which car parks operate should be considered as deterrents to antisocial behaviour. The police also recommended the introduction of CCTV to provide evidential support to any enforcement action that may become possible by police. Such measures exist in other local authority areas and police advised that they are a successful deterrent as stated at the meeting.

This implies that everyone using the car parks in the evening and on a Sunday will have to register their vehicle and check in and out. What evidence is there that perpetrators of anti-social behaviour will comply with this requirement? If they do not, how does this requirement assist with identifying them?

The Wokingham Borough-Wide Off-Street Car Parks Order 2021 will provide the Council with the flexibility to introduce the requirement to check in and out in the evenings and on a Sunday in the future, as the need to address any issue arises.

How will this requirement impact on residents who use the car park and forget to check in? Will enforcement officers be active 24/7? What is included in the policy that would avoid innocent residents being fined simply for failing to display a ticket during times when there is no charge for using the car park? How are residents being informed of the change, which will require them to have a ticket at all times, when previously there was no requirement and people used to using the car park would not even look at the ticket machines overnight or on a Sunday?

The Wokingham Borough-Wide Off-Street Car Parks Order 2021 makes no changes to the requirement for car park users to check in and anyone who forgets to check in will be liable to penalty just as they are now.

Enforcement officers will be active for those periods when enforcement is necessary to ensure that car park terms and conditions are being met.

Residents will be informed of the requirement check in or obtain a ticket on signs within the car parks just as they are now. In the event that we are making changes to our car park terms and conditions we will of course ensure that these are appropriately communicated through the local press and our various social media channels.

The supporting CCTV will help to deter ASB, but can it be used to prosecute offenders?

Yes our CCTV can be used to assist in the prosecution of offenders.

Members have been told variously that the CCTV cameras were installed due to theft of catalytic converters, to reduce emissions caused by queuing cars, and now to deter ASB. Section 1.4.2 d) states there should be a presumption of 'openness'. This is not apparent here.

The CCTV cameras within our car park and out on the Borough highway network have primarily been introduced to reduce congestion, shorten journey times and enable residents to make effective choices on where to park. However, the same cameras are also capable of providing evidence of ASB and other crimes within our car parks and will assist us to address these issues.
