The report provides an update on funding information as it is currently available, and results of the consultation with schools and required voting.

### **SCHOOLS FORUM**

### **DSG Schools Block Budget Update 2024/25**

### 01. Purpose of the Report

This report provides Schools Forum with an update on 2024/25 budget setting.

### 02. Recommendation

Schools Forum is asked to note the update on the Schools Block budget for the 2024/25 financial year.

Schools Forum is asked to vote on the Disapplication request for our all-through school.

### 03. Funding Allocation for 2024/25

At the end of July 2023 the DfE advised Wokingham Borough Council of our Primary and Secondary Units of Funding for the 2024/25 financial year. The DfE subsequently sent through revised rates in October 2023.

Below is an updated table for Schools Block Funding. Our modelling shows that on average schools will receive an increase in their allocations of 5.5% compared to 2023-24.

### **OUTCOME / BENEFITS TO THE COMMUNITY**

This report forms part of regular reporting to Schools Forum, informing areas of statutory decision making and improving visibility and consultation on wider Dedicated Schools Grant (DSG) financial matters.

#### RECOMMENDATION

Schools Forum is asked for the following:

- 1. To note the outcome of the stage 3 schools' survey gathering views on the recommendation to support the request of the 0.5% transfer of DSG Schools Block budget to the High Needs Block in 2024/25.
- 2. To reach a decision as to whether to support the recommended transfer.

#### SUMMARY OF REPORT

The report presents the outcome of the schools' consultation regarding the request of the 0.5% transfer of DSG Schools Block budget to the High Needs Block in 2024/25.

This work builds on an earlier stage 1 consultation in June / July entitled 'Right Spaces, Right Places' that gathered Wokingham school views of the strategic priorities regarding Special Educational Needs and Disabilities (SEND) and proposed spending on SEND provision and support.

This was followed by a stage 2 consultation gathering views on the recommendation to support the request of the 1% transfer, which ran between 18/09/23 and 2/10/23 and showed a clear majority of 68% of schools were against the transfer, (although a majority of secondary schools were in favour).

The outcome of stages 1&2 were detailed in the report to Schools Forum on the 11<sup>th</sup> October 2023.

At the October meeting Forum members recognised the importance of the vote and requested the following changes:

- That the total requested transfer be reduced to 0.5% of DSG Schools Block.
- That the model for allocating this funding be adjusted to reduce the impact on primary schools and to shift more of the financial impact onto secondary schools.
- That the new model should be presented to all schools again and their views surveyed (recognising that the timescales for this were very tight)
- Forum agreed to hold an Extraordinary meeting on the 6<sup>th</sup> November to hear the results as to how schools voted regarding the new model and to reach a final decision as to whether to support or reject the requested transfer.

The new model was developed and approved by Friday 13<sup>th</sup> October and was emailed round to schools with a survey on Monday 16<sup>th</sup> October.

Schools have been offered an opportunity to meet the Council officers to explain and answer any questions that they may have. Over 20 schools took up the offer mostly during the last week of term for Headteachers and School Business Managers to meet the officers. Lead Member Cllr Prue Bray attended a number of these meetings and information was also presented to the Governor's Forum on Wednesday 18<sup>th</sup> October.

At the time of writing this report the voting remains open BUT it can be reported that there is now a clear majority (over 90%) in favour of the 0.5% transfer; a detailed breakdown will be provided at the Forum meeting on 6/11/23 but the majority is sufficiently large enough that it will stand regardless of how any remaining votes are cast.

### 6th November 2023

### 01. Purpose of the Report

To present the case for the transfer of 0.5% of budget from the Schools Block to the High Needs Block in 2024/25 and to present schools' views of this proposal based on a recent survey.

#### 02. Recommendation

Schools Forum is asked for the following:

- 1. To note the outcome of the stage 3 schools' survey gathering views on the recommendation to support the request of the 0.5% transfer of DSG Schools Block budget to the High Needs Block in 2024/25.
- 2. To reach a decision as to whether to support the recommended transfer.

### 03. Background

This report should be read in conjunction with the last report to Schools Forum regarding the proposed transfer from DSG Schools Block to High Needs Block presented on the 11<sup>th</sup> October 2023.

At the October meeting Forum members recognised the importance of the vote and requested the following changes:

- That the total requested transfer be reduced to 0.5% of DSG Schools Block for 2024/25: circa £740k.
- That the model for allocating this funding be adjusted to reduce the impact on primary schools and to shift more of the financial onto secondary schools.
- That the new model should be presented to all schools again and their views surveyed (recognising that the timescales for this were very tight).
- Forum agreed to hold an Extraordinary meeting on the 6<sup>th</sup> November to hear the results as to how schools voted regarding the new model and to reach a final decision as to whether to support or reject the requested transfer.

### 04. Report

### **04.i** New Funding Model

Following Schools Forum the new model was developed and approved by Friday 13<sup>th</sup> October.

The updated proposal would see a reduced transfer of a total of circa £740k schools block (0.5% of the total) for 2024/25 and was modelled to reduce the primary phase contribution slightly. Taking this transfer into account every school in Wokingham will receive an increased budget allocation next year totalling 5% across the system – although this ranges between 3.1% up to 6.9% depending on a number of factors.

There are constraints limiting how much flexibility the LA has in determining how this contribution is apportioned between schools; some schools are protected from contributing anything due to minimum funding guarantees. Of those that would contribute the level would depend on a number of factors but the overview looks like this:

### **04.**ii Engagement and Dialogue

Schools received individual emails showing the % impact of the new model on Monday 16<sup>th</sup> October with an attached survey and were asked to respond to Ming Zhang (Assistant Director Education and SEND) as soon as possible; replies were requested by the end of term (Friday 20<sup>th</sup> October) but the survey remains open until Friday 27<sup>th</sup> October for late replies.

Meetings were also offered to primary schools at short notice and officers met with over 20 schools mostly during the last week of term to explain the new model and take any queries from Headteachers and School Business Managers. Lead Member Cllr Prue Bray attended a number of these meetings.

Information was also presented to the Governor's Forum on Wednesday 18th October.

#### **04.**iii Outcome of Survey and Feedback

At the time of publishing this report the voting remains open BUT it can be reported that there is now a clear majority (over 90%) in favour of the 0.5% transfer; **a detailed breakdown will be provided at the Forum meeting on 6/11/23** but the majority is sufficiently large enough that it will stand regardless of how any remaining votes are cast.

The reasons given for the change of voting are summarised as follows:

- Most schools said they understood the reasons for the request and support the
  activity that is underway but that the previous request was unaffordable in the
  current financial climate.
- The significant reduction in the request from primary schools made this easier to accept.
- Some schools indicated that they wanted to see significant improvement in the coming year and that their vote of support next year was very much dependent on this progress being visible by the end of the year.

### **05. CONCLUSION AND RECOMMENDATION**

Given the fact that there is a majority of support from the majority of schools for the proposed improvement measures Schools Forum are asked to approve the 0.5% transfer of Schools Block to High Needs Block for 2024/25 as a commitment to the joint working required to reach a balanced High Needs Block budget by 2029.

October 2023 Survey on School Responses to Revised Proposal to Transfer 0.5% Schools Block budget to High Needs Block in 2024/25

Summary Analysis



- A school survey in September rejected the request for 1% transfer (68% against vs 32% for) affordability was the main reason given for the rejection particularly for primary phase schools
- As an alternative Schools Forum proposed a reduction in the amount of transfer requested to 0.5% of the DSG Schools Block and asked WBC to devise a funding model that will alleviate the pressure on primary schools.
- Forum asked WBC to consult with schools again on the amended proposals to establish whether this would be more widely supported.
- Wokingham Council ran this survey for schools between Friday 16th Monday 30th October 2023
   accompanied by a series of meetings with headteachers, governors and school business managers
- The survey was responded to by a total of 40 schools 58% of all local schools
- An Extraordinary Meeting of Schools Forum was called for the 6/11/2023 to hear the findings of this survey and reach a decision on the transfer.

- 80% of all secondary schools cast a vote and 100% of these supported the proposed transfer
- 55% of all primary schools cast a vote and 90% of these supported the proposed transfer
- 50% of all special / AP schools cast a vote and 100% of these supported the proposed transfer

This is a marked change from the survey in September; school's feedback was that the revised proposal was more affordable for primary schools and many headteachers said that they appreciated that their concerns had been listened to.
