Personnel Board met on 19 June to be note the changes in the People Services Directorate and agreed the summary of accountabilities to be included in the Heads of Terms for the Shared DASS trial arrangements. ***The Council faces severe financial challenges over the coming years as a result of the austerity measures implemented by the Government and subsequent reductions to public sector funding. It is estimated that Wokingham Borough Council will be required to make budget reductions in excess of £20m over the next three years and all Executive decisions should be made in this context.***
