TITLE District Licence update to Local Validation List

PURPOSE OF REPORT (Inc Strategic Outcomes)

To seek formal agreement for minor modifications of the existing Local Validation List so that it includes additional details in respect of the District Licensing Scheme now available to applicants for planning applications where the application site falls within protected species (Great Crested Newts) zones.

The scheme is offered as an alternative to provision of species protection mitigation reports & the associated licensing currently required – the applicants will be offered the choice to use the new licensing scheme as an alternative.

RECOMMENDATION

That the Executive Member for Planning and Local Plan approve the minor modifications to existing Local Validation List as outlined above.

SUMMARY OF REPORT

Background

The Planning Regulations require certain plans and documents to be submitted in order to make an application valid. The Regulations allow Local Authorities to require further supporting information provided it is set out on a "Local Validation List". Wokingham Borough Council's Local Validation List was last updated in 2021.

Great crested newts and their habitats are legally protected in the UK and must be considered as part of the planning application process. Unless it can be definitively demonstrated that there is no risk to great crested newts or their habitats, applicants need a licence to carry out development work where the species and or its protected habitats are present.

Wokingham Borough currently offers two licensing options, these are:

- applying directly to Natural England for a licence after you have received planning permission; or
- by working with a registered ecologist under the low impact class licence

The Council can now offer a third option for applicants whose sites are located within protected species zones;

• joining the District Licence Scheme authorised by the Council as part of the planning application process

Business Case (including Analysis of Issues)

No business case required – this report seeks to make minor modifications to the Council's existing Local Validation List, there are no associated financial implications.

FINANCIAL IMPLICATIONS OF THE RECOMMENDATION
