
LTP4 Consultation

A. Consultation Plan

We will develop a Consultation Plan with a particular focus to secure comment from groups 17 and younger, 18-24 and of working age (i.e. under 65). This is because the latter group comprised almost two in five of all responses (38%) in the spring 2023 engagement yet accounting for 17% of the borough's population; responses from those under 24 comprised just 0.5% of all respondents.



We will detail ways to target those in education (21 and younger) and SEND groups, religious minorities and people of working age.

We also need to secure a greater/representative response from the rural areas in the north of the borough and parts of the south west (Swallowfield and Arborfield & Newland).
