These events boost the image of centres and encourage people to visit at other times. Discouraging people from visiting is counter productive. <p>I am particularly concerned about the proposed charges in Polehampton Close in Twyford. I strongly object to this proposal. As it stands there is already a charge during the day which mostly affects commuters using the station as the station car park is not big enough. However in the evening this car park becomes a community resource. The old Polehampton School is the headquarters of The Twyford and Ruscombe Theatre Group who use the building in the evenings for rehearsals and at weekends for set building and painting. The Polehampton Close car park (which was originally part of the school grounds), is therefore used by members of the group on several evenings and at weekends. Should you impose this new car parking charge this could have a devastating effect on the viability of the Theatre Group as this could effectively prevent members being able to use the facilities without huge expense. Surely you do not wish to have such an adverse effect on this successful Theatre Group which has been operating happily out of the Old Boys School virtually since the school ceased using it. I also wonder if you are aware of the plans to develop the site as a community hub. A planning application for this has already been submitted and it would seem a little premature to add new car parking charges just before this proposal is being considered. As it is we have had to contend with the toilets being closed without any consultation with the occupiers of the school (they were our only toilets) and now you intend to prevent us parking there as well. It does rather give the impression that Wokingham District Council are not very supportive of our community resources in Twyford. I should be very interested to know the purpose of the charge apart from purely raising money? If you add car parking charges to this community used car park we shall then, as a community group, have to apply to the council for assistance to help pay the charges otherwise we might fold. There is a good reason why we have not increased our membership charges for over ten years, we do not want to deter people from supporting us. I fully accept that many of our members could easily afford the additional cost. However those that will find it most difficult are the younger members, whom we are most keen to attract and retain. Without the next generation of members we could easily become yet another geriatric social club, destined to close down as members expire!! <p>I completely disagree with the proposal to introduce charges. In the last 2/3 years Wokingham has seen a decline in retailers in the town centre because of increased rents and increased traffic problems leading to a lack of customer flow during the day. The result of this is empty premises and an increase in food establishments who benefit from the free parking and reduced congestion. If charges are to be applied in the evenings then what is the advantage of visiting Wokingham over Reading (where there is far more choice), or Bracknell where huge redevelopment is being completed. This move would lead to driving more people out of our local town. If the huge amount of food places were to close, who exactly would take over these premises? I am proud to live in Wokingham and support the town and do not want to see it become full of low rent shops brought in to fill premises and become like any neglected town in the UK. It seems a short sighted move to impose car park charges to increase council revenue when the end result will be empty premises which will ultimately affect the rents and taxes paid to Wokingham. <p>I have a few comments regarding the proposed change to charge for car parking after 6pm in the car parks in and around Twyford village :</p> <ol style="list-style-type: none"> <li>1. This is likely to have a negative impact on surrounding areas, as these car parks are frequently used by local theatre groups and evening pub/restaurant visitors, who are likely to park on the roads rather than pay the £1 charge - this may be for a variety of reasons such as not having correct change, or just plain avoiding the charge.</li> <li>2. Having coin boxes containing cash out of hours may lead to a rise in petty theft/antisocial behaviour as they may be seen as soft targets for a few quid - even one or two incidents per year of this type would wipe out any revenue benefit to the borough as a whole with the associated policing and security costs.</li> <li>3. To be of any benefit to the wider community, such measure would surely need to be enforced, with the associated additional cost to tax payers. I would suggest the cost of additional patrols/wardens would not be covered by the rather modest additional revenues and costs associated with this suggestion as on many evenings the car parks are likely to remain pretty empty (given 1. above).</li> <li>4. Such a measure is not really in the interest of the local community, or supportive of evening social groups, charities and the like who are the main users out of hours - this change is likely to be seen as just another small revenue grabbing exercise by the council, which is neither in the interest of WBC or the local village community. <p>I do not agree with the proposed changes for the following reasons: 1. There will likely be an impact on local businesses that rely on Sunday and evening trade, particularly coffee shops and take-away food retailers who are located close to car parks which are currently free during those periods (eg. those in Woodley centre close to Crockhamwell car park). Some councillors and others will suggest that paying £1 will not affect people visiting such businesses, but can those people honestly say they have conducted genuine research on the issue or is it just gut feel or that they saying that because it justifies the outcome they want ? Small punitive changes can indeed change people's behaviour - take the 5p carrier bag charge from supermarkets - it's a very small charge and probably less than 1% of a typical supermarket shop, yet almost instantly reduced carrier bag supply by over 80%. It's not the 5p that people object to, it's the principal that matters and drives change in behaviour. The same applies to car park charges - charging for something that people think should be free will drive change in behaviour and evening/Sunday usage will fall, affecting businesses accordingly. 2. People will park on roads instead, impacting residents on those roads (eg. Silver Fox Crescent, Roslyn Road in Woodley). You could paint double yellow lines along these roads, or increase the times that parking is not allowed on the single yellow lines to include evenings and weekends, but this still affects residents and makes it difficult for visitors to residents on these roads. 3. The cost of enforcement - Taking Crockhamwell Road as an example - mid week evenings this car park is not heavily used - it will not generate a large income, especially if even less people park there in the evening once charging is implemented (eg. me - I'll park outside peoples houses and walk into town instead). The cost of enforcement will surely outstrip the income from fining people if they don't pay. 4. <p>There are numerous reasons why this is a poorly thought out scheme. Those I fail to mention will no doubt be raised by others. This action will have the effect of driving business away from the shops and services located near to the car parks in question. Shopper will go to shops that offer free car parking. If shops lose business they may cease to trade. Who will pay your their business rates then ? But most worryingly for me is this entry level charge of £1. To be effective, the new charges will have to be policed either by council staff or whomever it is sub-contracted to. It is highly probable that the additional cost to police this new scheme will not be covered by the revenue generated from the car parking fees. So the fees will have to increase and you can rest assured it will not an increase determined by inflation. I have to use the Easthampstead Road East car park, every day and from there have to walk down to my house. I have to park there in the evenings and at weekends. I already have to pay to park my car there all day on a Saturday, which is what I would expect to have to do. However, I should not be expected to pay to park during the evenings and on a Sunday in addition to the vast amount of money I already have to pay for Council Tax. What benefit do I gain from paying this money? I have no alternative but to park my car in that car park. I would expect residents without access to on street parking are provided with free parking permits to cover the hours you intend to start charging for. This would not involve a large amount of properties, as the vast majority of houses on the London Road have drives (or room to park their car) beside their property or are able to park on the road outside their house. I do not have either option. I would of course be expecting to pay for parking in the usual way during 'normal' hours ie week days until 6pm and all day on Saturday to 6pm. I object to the proposed Sunday / BH / evening car park charges in the car park around Woodley shopping centre. I feel very strongly that this will have an impact on local shops in the Woodley shopping centre as well as amenities such as the library and Oakwood Centre. Small shops in Woodley are being financially hit by lower footfall these days as more people drive to supermarkets who have free car parks. I feel that this implementation of car park charges will cause some of the shops to go out of business or be closed down by their head offices due to reduced revenues. This will also drive many shoppers to park in nearby local streets to avoid extra charges causing bigger pressure on nearby roads. While you may think that £1 is not much extra to pay - it really is too much extra for many of us. I try to walk or cycle as much as possible to Woodley shopping area but on some odd occasions I have to drive and that is when the car park charges will force me to avoid it. For example if I need to use the car park for less than 5 mins to drop off a library book on my way home from work one evening - why should I pay £1 for those 5 mins? If I wish to put items in the recycling bins in Headley Road car park on a Sunday or evening - why should I have to pay £1 for the privilege of recycling? You should be encouraging locals to use facilities such as the library, Oakwood centre and recycling area - not making residents pay additional money to use them. I also don't believe you should be implementing evening and Sunday charges at Winnersh Triangle. You should be encouraging people to use the train as a public transport not discouraging them. Councils are supposed to work for local residents and businesses - not against them! I strongly object to this proposal and request that you do not implement it.

I am a resident on Rose Street, Wokingham. I pay for a residents permit for the handful of spaces available in my street. They are like gold dust and it is rare that I can ever get one. As a result, the only parking available to me is either parking on the road for the free 30 mins allowed until 6pm when it becomes free until 8am, or paying for parking in the local car park until the same free hours. What you are proposing will mean that my parking charges, as a resident, will sky rocket. The knock on effect will be that non-residents will now take over the road space that is available to us as residents evening and night time. Non-residents will currently often use the car parks over night if they are dining and drinking in the town and then pick up their cars in the morning. The logical outcome is that they will now move to the street spaces, making it more problematic for us. As it is, the number of allocated spaces allowed for residents is shameful, and this will now become even more challenging. I believe that street parking in the town should primarily be made available to residents before any consideration is made to impose further parking charges in local car parks. And not just the 11 or so specified spaces that are currently available in my street, but the whole street. I already have issues in that I can't get a visitors permit for my street, so visitors already have to pay ridiculous costs to stay with me. I pay very high council tax, but because I live in the centre of town, I don't have the luxury as those who live in estates outside of the centre of town do, where street parking is free and readily available. As a renting tenant I have already had my choice of where to live narrowed to almost no choice at all in such a saturated market, paying premiums on pretty much all expenditures, and now you propose this? Potentially £292 a year so that I can park overnight in my own street, outside my own home? Despicable. It will be residents, primarily, who will shoulder the cost of your proposal. And for what benefit? Yet more inconvenience, yet more expenditure. I wish to object in the strongest possible terms to the introduction of Sunday and evening parking charges, particularly in Wokingham town centre. As far as I can see no consideration has been given to the impact on neighbouring streets, particularly those which have no permit parking. My street, Gypsy Lane, is already completely clogged every morning Monday-Saturday as commuters and local workers fight to take the free spaces available outside 41-53 Gypsy Lane. The only solace is that a few spaces will generally emerge around 5pm or 6pm when they leave when residents come back from work, although should we ever invite friends around or get a workman in, it is an absolute nightmare since no spaces are ever available in the day. By introducing parking charges in the evening, this will encourage other non-residents to park overnight in this area, further denying residents access. Personally I would advocate the introduction of permit parking in central areas anyway, it is hard to understand the rationale as to why some central streets have it such as Howard Road and Norreys, while others do not. However if you are unwilling to do this, then I feel there is no way this parking plan can go ahead, especially without a study on the impact on neighbouring roads. Of course even as I resident I appreciate I have no right to park close to my house. But I pick out some quotes from British Parking position paper 4 regarding onstreet parking, it would be great if you follow best practise and consider them.

"Parking controls should be introduced to prevent commuters from parking in residential areas....."  
A further problem is that as a street becomes congested with parked cars it is easier for vehicles to be abandoned unnoticed thereby restricting parking supply even more  
The time spent and environmental pollution created when searching for a vacant parking space is another effect of the limited on street parking supply.  
Part of the problem could well be caused by local authority planners often not giving due regard to the likely demand for parking spaces and where or how that demand would be accommodated.  
To facilitate the unhindered passage of traffic along a road ensure that busy roads have a useable width of 7 metres, less busy routes 5 metres, minor road 4.5 metres, minor residential roads 3.5 metres.

I am writing with regard to the notice informing of the local parking charges that I spotted by the pay machine at Woodley precinct this morning as I dropped my daughter off at nursery. I have some concerns that I would like to bring to your attention with regard to this scheme. My main source of worry is the prosperity of the precinct. For clarity, I do not generally drive to the precinct on a Sunday, if I go, I walk or cycle as my home is less than half a mile away. I have been a life-long resident of Woodley and Earley, with Woodley Precinct part of my daily shopping habits since the first pocket money that I received. Over the years, I have watched the precinct descend from prosperity to a virtual slum and now back to something that we can be almost proud of. I put much of this down to the hard work of the centre management who have clearly embarked on a number of initiatives to drive footfall over the years and this has largely been successful. My arguments against the scheme are as threefold and as follows: 1. Competition Asda, Tesco and Sainsbury's all have hypermarkets within a few miles of the centre who offer free parking. In the knowledge that an additional 5 minutes in the car for those living over a mile away will save £1, I can't help but think that this will damage trade. 2. Passing Trade £1 to park on a Sunday at a shopping centre that is at best 50% open on a Sunday seems quite rich. Any passing trade is almost certain to be put off. On a Saturday or weekday, I don't think that this is an issue as people plan ahead and there are plenty of open, small and local alternatives. I do recognise that I will however frequently stop by to grab a handful of groceries on my travels on a Sunday or on my way home from work. If I have to pay to park, I just will not bother, I'll stop in Theale as I pass through on the way back home (not good for our own local economy but it's free to park in their town centre). To give an example of this shopping behaviour, last week, I stopped at Lidl or Waitrose three times on the way home, spending between £3 and £9 each time. Averaging this at £15 per week, this initiative would take around £705 per annum from me alone out of precinct retailers tills (based on a 47 week working year). As I doubt I am the only one that will adopt this attitude, I can't see local traders welcoming the initiative. 3. Value It seems insane that it would cost more to park for 10 minutes at midnight on Tuesday than it would at 2pm on a Saturday! I appreciate that times are hard at the council with central government cutting service subsidies, however potentially damaging local trade for small

Our new start up business has a growing night time and weekend economy and hence would be significantly negatively impacted by the proposal. Issues are:- 1) Damage to our new business by the removal of the sales feature of free evenings and Sunday parking which attracts clients who may be charged elsewhere. 2) The additional cost of parking monitoring, staffing and administering such additional periods may actually increase costs to the council? 3) The tenants of the increasing number of refurbished and new flats would either have to pay for overnight vehicle parking or displace their vehicles to surrounding residential street with the issues that would raise. 4) It is not clear from the proposal documentation if those who pay for period permits would have to pay significantly more to cover the new charging periods - impacting the ability to draw in staff with vehicles who have long of variable shift working patterns. 5) Car park usage at night is less than during the day and it is assumed there are no figures available to show how much can be raised in revenue form night time and Sunday parking? There is information on daytime figures, hence a more reliable source of predictable income if current parking charges were raised. 6) Shoppers have choices and parking is an emotive subject. Eliminating free parking periods may deter shoppers/clients and displace them to other centres with more faculties and outlets. 7) There are no benefits offered in this proposal to offset the charges proposal. The parking machines are antiquated and often Out of Order. There is no change facility or features such and paying by Card/Contactless payment/payment for time actually spent etc. Whist it is understood the Council have a cut in funding and has to make choices we would like to offer an alternative. Given that at a time of low inflation any increase is potentially damaging to business and unwelcome; increasing the daytime charges would provide a more predictable revenue at very little additional cost. <p>Clearly you are expecting people to be upset and object to the introduction of evening and Sunday charges to the town's car parks (and start charging for the Shute End car park). I currently enjoy the ability to park freely at these times and also struggle with the general lack of parking at peak times (Denmark St and The Paddocks are often full) and do not like the introduction of charges. However I find the stated logic for the introduction of charges totally incomprehensible. Contrary to what Cllr Kaiser says the car parks are not free and I'm sure the income from the car parks is far greater than the cost of running them (clearly except Shute End which is not primarily a public car park). The suggestion that they become more 'self sufficient' implies that they are currently subsidised and that they will continue to be subsidised (to a lesser extent) once the new charges are introduced. I do not expect that any notice will be taken of objections but if you are going to try to sell it on the basis of the rationale given then this really needs to be backed up with figures (current income, cost and anticipated increase in income) as I, and probably many others, simply do not believe the rationale stated, which undermines trust in the local council. I would also like more information on the 'best value' comments, particularly I would like to understand the negative impact of not introduces these charges. I can understand the need to generate income from car parking, particularly if we all want to keep our council tax bills as low as possible. However, I feel that it could cost more to administer an evening/all night charge than revenue collected. From a personal point of view, I may have to carefully consider whether to travel to Woodley in order to attend meetings etc at the Oakwood Centre. The proposed increase could add an estimated £30 to the cost of attending meetings there. £30 is a significant amount of money to people who are retired or otherwise on reduced incomes. Living outside Woodley it isn't practical to suggest that we travel to the town centre by bus, or other mode of travel (particularly on dark winter nights which tends to be when most club activity occurs. If people start to budget in order to take the additional cost of parking into account, then there could be a knock-on effect of clubs losing subscriptions and/or the Oakwood Centre in turn suffering a reduction in its use. With loneliness a factor leading to poor health, and hence a potential burden to local healthcare, surely, for the sake of the loss of revenue in the evenings, then social contact via the Oakwood Centre more than repays the social costs of potential loneliness and ill health. On the evening when I use the car park I observe that most people are of retirement age. As for Sundays. I once believed that Sundays should be spent with the family and that shops should be closed. However, in these modern times, if local shops wish to compete with out of town superstores then they also need to open 7 days a week. It is possible that an introduction of car parking charges on Sundays would discourage people from shopping locally and the town centre could, possibly, die. What then? There may be a reduction in income from business rate. If you do proceed with introducing said charges, perhaps they could be introduced on a trial basis e.g. maximum of one year, in order to monitor the effect on local businesses and clubs. Please bear in mind that the greatest impact is likely to be in the autumn and winter months.

<p>I attended a meeting this week of the Woodley Town Centre Management Initiative Committee (WTCMI) which was attended by the Committee, Town Councilors and residents where amongst items for discussion was the proposed increase in car parking charges. We understand that cuts in grants from Central Government mean that Wokingham Borough Council have to try and make up the shortfall where they can without cutting vital services. The Town Council, the WTCMI and all attendees at the meeting feel strongly that this proposal of evening and Sunday car parking charges would be detrimental to any activities held in the evening at Oakwood Centre or in the Woodley Town Centre. For example the Woodley Arts Group; the Photographic Society; Woodley Ladies Group etc. I understand that the Oakwood Centre struggles sometimes for bookings this proposal would deter any future bookings and also I feel the membership of various clubs and societies would decrease over time. We do not want our Town Centre to become a dead zone. The Town Council propose a counter solution to increase the week daytime charges, say, from 70p per hour to 80p per hour; all other charges to remain the same. As you have precise figures of the daytime use of the car parks you know exactly how much revenue this small increase would produce whereas the evening use is unknown and unpredictable. The above proposal was supported by the WTCMI, residents and users of the Oakwood Centre. Below are listed some of the organisations I have researched, that meet after 6pm and will be affected: Wokingham Mencap, Guides, Beavers, Brownies (3rd Wokingham), Brownies (4th Wokingham), Church Choir, Wokingham Trefoil Guild, CONTACT, Lace Makers, Wokingham Philatelic Society, Wokingham Horticultural Association, Wokingham History Group, Wokingham Art Society, Pilates, Loddon Valley Ramblers, Railway & Transport Club, Table Tennis Club, Yoga in Pregnancy and many more. I strongly object to these evening car par charges for the following reasons: The above organisations and many more are run by volunteers and charge minimal prices to keep the organisations going and are a huge benefit to the community spirit, cultural and physical development and mental well-being in the town. The extra burden of evening car park charges will restrict the many, particularly the lesser well-off, from getting the benefit and pleasure of participating in evening activities.

Opposition to the proposed introduction of Evening and Sunday Car Park charges in Woodley. Woodley Theatre is an amateur theatre that has been in Woodley for 70 years. The Oakwood Centre is the home of Woodley Theatre. Woodley Theatre presents at least 5 productions/plays a year lasting for at least 5 performances. We also produce Jazz Concerts which are very well supported particularly by the older members of the community. The majority of members of Woodley Theatre and their patrons use the public car park in Headley Road, Woodley which they find safe and a short walk from the theatre. All rehearsals and preparation for productions are held at the Oakwood Centre when the car park is used by the membership. We oppose the introduction of Evening and Sunday Car Parking charges which will have an impact on both our membership and our audiences. For members who are taking part in a production the financial implication will be considerable. For our audience it will add to the cost of the evening which we have been trying to keep to a reasonable cost. We urge you to rethink this proposal. The impact on Woodley Theatre will be considerable and certainly affect the membership and audience numbers, encouraging many to go elsewhere. There are no other amateur theatre within the Wokingham Borough or Reading that have evening or Sunday parking charges. We support the proposal made by Woodley Town Council to increase the daily hourly charge by 10p. The daytime use of the car parks are considerable and this would make up the financial shortfall which we understand is the reason for the proposal. Woodley Theatre wish to continue to provide high quality theatre for the local community. Introducing Evening and Sunday charges is likely to see this greatly reduced or even lost. Please reconsider the introduction of Public Car Park evening and Sunday charges.

This car park is used by members of the Twyford and Ruscombe Theatre Group (a local amateur dramatics society) attending rehearsals at the Old Polehampton Boys School in the Close every Tuesday and Thursday from 8 to 10pm and occasionally on Sundays. This proposed charge would effectively add from £50 to £100 to the existing membership fee of only £15. This will be a strong disincentive for members to participate in this social activity and could put the drama group's very existence into jeopardy. 2. The usage of this off-street car park during the evenings and on Sunday is minimal and so there is no need to control congestion of it during these times (unlike during weekdays). Your Dinton weekend charges are terrible, I go for an hour with the dog, I don't want to pay £1.50 for that, and I don't want 4 hours. For weekends you need to offer the one hour option. Over time you will see a fall away of usage, and don't say I get good services for my £1.50 - have you walked the dog walk from the main carpark lately, in particular the path where the lorries serviced the new play area, it's appalling. And don't say you provide dog waste bins - at 8.00 on a Sunday morning they are stuffed full, they are not emptied enough, WBC is taking money and NOT providing good service, you need to remember it's the public that pay your salary, so keep us happy and be reasonable.

<p>The Woodley Town Centre Management Initiative (WTCMI) response to WBC Evening &amp; Sunday parking charges proposal. At our quarterly meeting on 27 January 2016 the Woodley Town Centre Management Initiative (WTCMI) considered the proposal from Wokingham Borough council to introduce evening and weekend parking charges in the Borough Council's car parks. The Woodley Town Centre car parks, in Crockhamwell Rd, Headley Rd, Lytham Rd East &amp; West currently do not charge for parking after 6pm and all day on Sundays &amp; Bank Holidays. For many years the Woodley Town Centre Management Initiative has been working hard to encourage visitors to the Town Centre and has been successful in recent years in increasing Sunday trade. Evening use of the Town Centre has also recently increased with the openings of a large bar, a restaurant, a dance school, bringing the Town Centre to life and helping reduce antisocial behaviour. Waitrose, Lidl, Iceland and several take-away shops also trade much later than 6pm. The regeneration is continuing with plans to improve the northern end of the Town Centre, which should take place later this year &amp; help further encourage a night-time economy. The Town Centre Management Initiative believes that the proposal for new parking charges in the evenings and on Sundays in the car parks surrounding the Woodley Town Centre would reduce footfall and be detrimental to retailers, shops and businesses in the shopping centre and be a serious blow to its competitiveness against large supermarkets that have free parking on their premises. Some retailers in the Town Centre have already been affected by the arrival of M&amp;S food at the Shepherds Hill roundabout, which has free parking on their premises. Parking charges are unpopular in Town Shopping Centres but this proposal would be sending a negative message claiming that now: "Woodley Town Centre charges 24/7" for parking. Currently Woodley Town Centre can claim that at least in the evenings and on Sundays it welcomes customers without parking fees but if this is no longer the case, visitors and customers might choose to go elsewhere and hardworking retailers suffer even more. A Town Centre is the heartbeat of a community and a community needs a successful Town Centre. The nationwide Mary Portas bid was trying to help and boost Town Centres throughout Britain for just that very reason. <p>I'm responding to the proposal to begin charging for evening and Sunday use of woodley car parks. This is in my capacity as an independent retailer and in support of the letter sent by woodley TCMI This proposal will have a negative effect on the image of woodley shopping centre at a time when the retail environment has reached a fragile state. Recent business closures have included Cargo,Fabric Warehouse and Curves. These closures haven't happened because business is so good. Although there has been some improvement,footfall in Woodley is way below where it was some years ago and recently shops have been very quiet. If the borough wants a thriving shopping centre with successful businesses contributing rates,then more needs to be done to encourage people to visit. We have a hard working town centre manager who does his utmost to promote the centre,but he has no control over the car parks that people have to use when they visit. The fledgling night time economy needs support to continue to grow and charging its clients to use it will have the opposite effect. Equally Sunday visits to woodley are often by families who are coming to browse the car boot sales and spend leisure time in the cafes. There's nothing leisurely about "come on,drink up,the ticket runs out in 5 minutes". This is a very negative message to send out to visitors and local residents and negativity breeds more of the same. TCMI is a partnership and all parties should be looking for ways to persuade people to use Woodley not to give them a reason not to come or cut their visit short. I believe that woodley shopping centre itself should be looked at as a business with its product( shops ,cafes,environment etc) being presented at their best and being promoted by the TCMI partners. This promotion could include special offers with well advertised parking discounts for quiet periods,variable charging at busy times (law of supply and demand),and parking loyalty cards ( after 10 hours use ,get an hour free). Let's turn the negative image of car parking ( which still exists in woodley) into something with a more positive image that gives the car park users a good feeling from the perceived value of the ticket they've purchased. All of this could be achieved if the car parking technology was moved into the 21st century where the machines accepted debit cards and could engage with users in real time to inform them of that day's / week's special offer. The regeneration is continuing with plans to improve the northern end of the town centre, which will take place later this year, to further encourage a night-time economy.</p> <p>Woodley Town Council's Oakwood Centre, opposite the Headley Road car park, provides a social facility for the residents of Woodley and is used by local community clubs and as a venue for a variety of activities in the evening. The Centre is also the home of Woodley Theatre. <p>It has recently been brought to my attention that Wokingham Borough Council have in place proposals to apply overnight and Sunday charging for all their car parks. I am writing on behalf of the Executive Committee of the Wokingham Society to object to the proposed introduction of a £1 parking charge for evenings and weekends. While we appreciate the difficult financial circumstances which the Council faces in the light of successive cuts in central government grant, we are convinced that this is not an appropriate measure to increase income to the Council. Firstly it would be damaging to the local economy at a time when it is fragile and when steps are being taken to enhance retail and leisure opportunities in town centres, particularly with regard to Wokingham town. This would affect revenue in respect of those enterprises which rely for much of their income on evening and weekend trade and put at risk the potential benefits of the Council's investment in regeneration and in seeking to support the 18 hour economy. In addition, the Bank Holiday charge would adversely affect the festivals and carnivals local people work so hard to run for the benefit and enjoyment of the local community. Secondly there is a safety risk to people on their own, especially single females, in having to leave their cars and to find and feed a meter. They may well be deterred from coming into town and would thus feel excluded from the retail and social facilities otherwise on offer to them. Thirdly, and contrary to claims of direct comparison with other local centres which are said to have such charges already, parking is free at the affected times to those in Windsor and Maidenhead who have a free Advantage card; in specified car parks in Henley, and also in Marlow, which additionally has a number of free car parks. Thus people in this wider area will have a good reason to avoid Wokingham Borough and go to these other centres for their retail and leisure activities in the evenings and on Sundays. Fourthly, assuming that the charging method will continue to be payment on entry, there will be the practical inconvenience for those who wish to extend their afternoon stay into the evening and who will have to return to their vehicles to pay the £1 charge at some inconvenience, or who may decide not to stay once they have had to go back to the car park. In this last respect, we are assuming that those who know they want to stay beyond 6pm will be able to pay the £1 charge at the same time as they pay their initial parking fee, otherwise the same arguments of inconvenience will apply. Lastly, we would urge clarification as to whether the charges will apply to the new Carnival Pool Multi-Storey Car Park and in due course to the new Paddocks and Elm Field food store car parks. I wish to object on the grounds that there has been insufficient time to allow proper consultation on this significant proposed change to the existing regime. 28days would be more appropriate. I also think that a sufficient period of free time after 6pm should be allowed to enable people to carry out a quick shop on the way home from work or to collect takeaway food from the various establishments in Woodley precinct. It is very unfortunate that after having waited so long to have some decent restaurants in Woodley you are potentially driving customers away to other areas where there is free parking available.

I am concerned about these proposed changes to car parking - an evening/overnight charge, Sunday charges and making Shute End car park chargeable. Where I start is from the article in the Daily Telegraph (18/7/15) headlined "Free parking to save the high street" and the call from Marcus Jones ("high street minister" at the time) to allow shoppers to park for free to save shops from closure. Wokingham Town Council made a comment 2 years ago asking for the first 30 mins to be free to encourage users to the town. In the News Release ("Budget consultation : your comments published 14th December) the suggestion was made that evening and Sunday charges would raise between £75K and £110K. This was backed by 11 people and opposed by 2. Concerns were raised about the impact on the town centre and its 18hour economy and questioning how it would be enforced. As there is no Borough wide parking strategy it is difficult to agree with your proposals. Further the RAC were reported in the Bracknell News Weekender that Wokingham car parks made a surplus of £793K in 2014/15 so where is the justification for any increase. The Daily Telegraph report earlier on makes clear that Councils should not be using parking charges as a "cash cow" If the Council had a strategy then it would need to take into account the impact of the town centre regeneration. That was an attempt to increase its footfall and much of it would be people coming by car and parking. The supporting documentation for this proposal makes no reference to regeneration even though in 2016 work will start and finish on the new multi-storey car park and while work is being done a temporary car park will be made available along Elms Road. When I asked a question at the Executive last week I was told that the aim was to produce an extra £150K in 2016/17 but there was no information about where these amounts would come from - evenings, Sundays or Shute End. Already we know that due to increased usage car park revenue is expected to be £75K up for this year. This TRO is premature, incomplete and takes no note of the impact of the regeneration. I would urge you to re-introduce it in 3 months when work starts on the Carnival Pool site and the Elms Field planning application is determined. It may also give you time to consider the impact of the enlarged station car park. While the delay takes place perhaps the existing car parks can be looked at to see if any more spaces can be created. For example the 3 new disabled parking spaces on Rose Street may free up 3 spaces in the Rose Street car park. The lower Elms Road car park,
